5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. The heading to Subtitle H, Title 2, Government
7	Code, is amended to read as follows:
8	SUBTITLE H. INFORMATION RESOURCES AND PRIVACY
9	SECTION 2. Subtitle H, Title 2, Government Code, is amended
10	by adding Chapter 92 to read as follows:
11	CHAPTER 92. PROTECTION OF PERSONAL IDENTIFYING INFORMATION OF
12	AT-RISK INDIVIDUALS COLLECTED AND STORED BY DATA BROKERS AND OTHER
13	PERSONS
14	Sec. 92.001. DEFINITIONS. In this chapter:
15	(1) "At-risk individual" means:
16	(A) a judge, as defined by Section 33.001;
17	(B) a court clerk; and
18	(C) an employee of a state court, a court clerk,
19	the office, or another agency in the judicial branch of state
20	government.
21	(2) "Court clerk" means the clerk of the supreme
22	court, the court of criminal appeals, a court of appeals, a district
23	court, a county court, a statutory county court, a statutory
24	probate court, a justice court, or a municipal court.

1	(3) "Covered information":
2	(A) means:
3	(i) a home address, including primary and
4	secondary residences;
5	(ii) a home or personal telephone number,
6	including a mobile telephone number;
7	(iii) an e-mail address;
8	(iv) a social security number or driver's
9	license number;
10	(v) bank account, credit card, or debit
11	card information;
12	(vi) a license plate number or other unique
13	identifier of a vehicle owned, leased, or regularly used;
14	(vii) the identity of a child younger than
15	18 years of age;
16	(viii) a person's date of birth;
17	(ix) information regarding current or
18	future school or day care attendance, including the name or address
19	of the school or day care, schedules of attendance, or routes taken
20	to or from the school or day care;
21	(x) employment information, including the
22	name or address of the employer, employment schedules, or routes
23	taken to or from the employer's location; and
24	(xi) photographs or videos that reveal
25	information listed in Subparagraphs (i)- (x) ; and
26	(B) does not include information regarding
27	employment with a state agency.

1	(4) "Data broker" has the meaning assigned by Section
2	509.001, Business & Commerce Code, as added by Chapter 963 (S.B. No.
3	2105), Acts of the 88th Legislature, Regular Session, 2023. The
4	term does not include a commercial entity that:
5	(A) is engaged in the business of:
6	(i) reporting, news-gathering, speaking,
7	or engaging in other activities intended to inform the public on
8	matters of public interest or public concern;
9	(ii) providing 411 directory assistance or
10	directory information services, including name, address, and
11	telephone number, on behalf of or as a function of a
12	telecommunications carrier;
13	(iii) using personal information
14	internally, by providing access to businesses under common
15	ownership or affiliated by corporate control, or selling or
16	providing data for a transaction or service requested by or
17	concerning the individual whose personal information is being
18	transferred;
19	(iv) providing publicly available
20	information using real-time or near real-time alert services for
21	health or safety purposes; or
22	(v) collecting and selling or licensing
23	covered information incidental to conducting the activities
24	described by this subdivision; or
25	(B) is engaged in business as:
26	(i) a consumer reporting agency subject to
27	Chanter 20 Rusiness & Commerce Code and the Fair Credit Reporting

         Sec. 92.002. DATA BROKER PROHIBITIONS. Notwithstanding any
27

- 1 other law, a data broker may not knowingly sell, license, trade for
- 2 consideration, transfer, or purchase covered information of an
- 3 at-risk individual or an immediate family member of the individual.
- 4 Sec. 92.003. PROHIBITION ON BUSINESSES AND OTHER PERSONS.
- 5 (a) Except as provided by Subsection (b), a person may not publicly
- 6 post or display on a publicly accessible Internet website covered
- 7 information of an at-risk individual or an immediate family member
- 8 of the individual if the at-risk individual, or the office, acting
- 9 on the individual's behalf, submits a written request to that
- 10 person not to disclose or acquire the covered information that is
- 11 the subject of the request.
- 12 (b) Subsection (a) does not apply to:
- 13 <u>(1) covered information of an at-risk individual or an</u>
- 14 immediate family member of the individual displayed on a publicly
- 15 <u>accessible Internet website if the information is relevant to and</u>
- 16 displayed as part of a news story, commentary, editorial, or other
- 17 speech on a matter of public concern;
- 18 (2) covered information that an at-risk individual
- 19 voluntarily posts on the Internet; or
- 20 (3) covered information received from a governmental
- 21 entity or an employee or agent of a governmental entity.
- Sec. 92.004. REQUIRED CONDUCT. After receiving a written
- 23 request under Section 92.003, a person, including a data broker,
- 24 shall:
- 25 (1) not later than 72 hours after receipt of the
- 26 request:
- 27 (A) remove from the Internet website the covered

- 1 <u>information identified in the request;</u>
- 2 (B) ensure the information is not made available
- 3 on any other publicly accessible Internet website or subsidiary
- 4 website the person controls; and
- 5 (C) identify any other instances of the
- 6 information that should be removed; and
- 7 (2) assist the sender in locating the covered
- 8 information that may be posted on any publicly accessible Internet
- 9 website or subsidiary website controlled by the person.
- Sec. 92.005. OFFICE PROCEDURES. The judicial security
- 11 division of the office shall develop a process by which an at-risk
- 12 individual can file a written request with the director of the
- 13 office to notify a data broker or other person, on the at-risk
- 14 individual's behalf, of a written request submitted by the
- 15 individual to remove covered information posted or displayed by the
- 16 person on a publicly accessible Internet website.
- 17 Sec. 92.006. TRANSFER. (a) Except as provided by
- 18 Subsection (b), after receiving a written request under Section
- 19 92.003, the person may not transfer the covered information to any
- 20 other person through any medium.
- 21 (b) Subsection (a) does not apply to:
- 22 (1) the transfer of the covered information that is
- 23 relevant to and displayed as part of a news story, commentary,
- 24 editorial, or other speech on a matter of public concern;
- 25 (2) covered information the at-risk individual or the
- 26 immediate family member of the individual voluntarily posts on the
- 27 Internet; or

1	(3) a transfer of the covered information:
2	(A) at the request of the at-risk individual; or
3	(B) as necessary to produce a request to the
4	person from the at-risk individual.
5	Sec. 92.007. CIVIL REMEDIES. (a) If the covered
6	information of an at-risk individual or an immediate family member
7	of the individual is made public as a result of a violation of this
8	chapter, the at-risk individual or the individual's designee may
9	bring an action in a court seeking injunctive or declaratory
10	relief.
11	(b) If the plaintiff prevails in an action brought under
12	Subsection (a), the court, in addition to issuing an order for
13	injunctive or declaratory relief, may:
14	(1) impose a fine of \$500 for each day the covered
15	information remains public after the date on which the order for
16	injunctive or declaratory relief is issued; and
17	(2) if the defendant is not a state agency, award to
18	the at-risk individual, or the individual's immediate family,
19	exemplary damages, court costs, and reasonable attorney's fees.
20	Sec. 92.008. CRIMINAL OFFENSE. (a) A person commits an
21	offense if the person intentionally posts covered information of an
22	at-risk individual or an immediate family member of the individual
23	on a publicly accessible Internet website without first obtaining
24	the consent of the individual whose information was posted and:
25	(1) the information is posted with intent to cause or
26	threaten to cause harm to or harassment of an at-risk individual or
27	a member of the individual's immediate family, and

- 1 (2) under the circumstances, harm to or harassment of
- 2 the at-risk individual or immediate family member is a probable
- 3 consequence of the posting of the information.
- 4 (b) For purposes of Subsection (a), it is prima facie
- 5 evidence of the intent to cause or threaten to cause harm to or
- 6 <u>harassment of an at-risk individual or a member of the indi</u>vidual's
- 7 immediate family if the person:
- 8 <u>(1) receives a written request not to disclose the</u>
- 9 covered information for safety reasons; and
- 10 <u>(2) either:</u>
- 11 (A) fails to remove the covered information from
- 12 the Internet website not later than 48 hours after receiving the
- 13 request; or
- 14 (B) before the fourth anniversary of the date the
- 15 business receives the request, the person reposts the covered
- 16 information on the same Internet website or another publicly
- 17 accessible Internet website or makes the information publicly
- 18 available through another medium.
- 19 (c) An offense under this section is a Class B misdemeanor,
- 20 except that the offense is a Class A misdemeanor if the offense
- 21 results in the bodily injury of:
- 22 (1) the at-risk individual whose covered information
- 23 was posted on the Internet website; or
- 24 (2) an immediate family member of the individual.
- 25 SECTION 3. Chapter 92, Government Code, as added by this
- 26 Act, applies only to information posted on an Internet website on or
- 27 after the effective date of this Act.

- 1 SECTION 4. It is the intent of the 89th Legislature, Regular
- 2 Session, 2025, that the amendments made by this Act to Section
- 3 92.001(4), Government Code, be harmonized with another Act of the
- 4 89th Legislature, Regular Session, 2025, relating to
- 5 nonsubstantive additions to and corrections in enacted codes.
- 6 SECTION 5. This Act takes effect September 1, 2025.
