A pharmacy benefit 12 manager is not required to comply with a provision of this 13 14 subchapter with respect to a plan expressly excluded by this subchapter from the applicability of the provision. 15 16 (b) This subchapter applies to a health benefit plan provided to a resident of this state, regardless of whether the 17 plan, policy, agreement, or contract is delivered, issued for 18 delivery, or renewed within or outside this state and to the 19 pharmacy benefit manager for that plan. 20 21 SECTION 2. Section 1369.602, Insurance Code, is amended by 22 adding Subsections (d) and (e) to read as follows: 23 (d) Except as provided by this subsection, a pharmacy 24 benefit manager must comply with the provisions of this subchapter

1 with respect to each health benefit plan administered by the 2 pharmacy benefit manager, regardless of whether a provision of this 3 subchapter is specifically made applicable to the plan. A pharmacy 4 benefit manager is not required to comply with a provision of this 5 subchapter with respect to a plan expressly excluded by this 6 subchapter from the applicability of the provision. 7 (e) This subchapter applies to a health benefit plan

8 provided to a resident of this state, regardless of whether the 9 plan, policy, agreement, or contract is delivered, issued for 10 delivery, or renewed within or outside this state and to the 11 pharmacy benefit manager for that plan.

12 SECTION 3. As soon as practicable after the effective date 13 of this Act, the commissioner of insurance shall repeal all rules 14 that are inconsistent with the changes in law made by this Act.

15 SECTION 4. The changes in law made by this Act apply only to 16 a health benefit plan that is delivered, issued for delivery, or 17 renewed on or after January 1, 2026. A health benefit plan 18 delivered, issued for delivery, or renewed before January 1, 2026, 19 is governed by the law as it existed immediately before the 20 effective date of this Act, and that law is continued in effect for 21 that purpose.
