A BILL TO BE ENTITLED

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- 5 SECTION 1. Section 1701.164, Occupations Code, is amended
- to read as follows:
- Sec. 1701.164. COLLECTION OF CERTAIN INCIDENT-BASED DATA 7
- SUBMITTED BY LAW ENFORCEMENT AGENCIES. (a) The commission shall 8
- collect and maintain incident-based data submitted to 9 the
- commission under Article 2B.0055, Code of Criminal Procedure, 10
- including incident-based data compiled by a law enforcement agency 11
- 12 from reports received by the law enforcement agency under Article
- 2B.0054 of that code. 13
- 14 (b) The commission in consultation with the Department of
- Public Safety, the Bill Blackwood Law Enforcement Management 15
- 16 Institute of Texas, the W. W. Caruth, Jr., Police Institute at
- Dallas, and the Texas Police Chiefs Association shall develop: 17
- 18 (1) guidelines for submitting in a standard format the
- report containing incident-based data as required by Article 19
- 20 2B.0055, Code of Criminal Procedure; and
- 21 (2) policies to ensure the quality and accuracy of the
- data in a report described by Subdivision (1). 22
- 23 (c) Not later than January 1 of every odd-numbered year, the
- commission shall review, and revise as necessary, the guidelines 24

- 1 and policies required under Subsection (b) to ensure that the
- 2 incident-based data described by Subsection (a) is of the quality
- 3 necessary to enable academic research and reporting based on the
- 4 data.
- 5 (d) The commission shall make available on the commission's
- 6 publicly accessible Internet website:
- 7 (1) other than any information that is not subject to
- 8 disclosure under Chapter 552, Government Code, the incident-based
- 9 data described by Subsection (a) in a format that enables the public
- 10 to obtain an electronic copy and readily access the information;
- 11 and
- 12 (2) a glossary of terms relating to the incident-based
- 13 data described by Subsection (a) that assists the public in
- 14 understanding the data.
- SECTION 2. Subchapter D, Chapter 1701, Occupations Code, is
- 16 amended by adding Section 1701.1645 to read as follows:
- 17 Sec. 1701.1645. STUDY ON IMPROVED COLLECTION OF
- 18 INCIDENT-BASED DATA. (a) The commission shall conduct a study on
- 19 the incident-based data described by Section 1701.164(a) and, based
- 20 on the findings of that study, make recommendations regarding:
- 21 (1) improving the quality of the incident-based data
- 22 <u>collected under Article 2B.0054</u>, Code of Criminal Procedure;
- 23 (2) reducing any redundant reporting or regulatory
- 24 requirements; and
- 25 (3) the feasibility of:
- 26 (A) collecting and reporting data not subject to
- 27 Article 2B.0054, Code of Criminal Procedure, regarding encounters

- 1 between peace officers and members of the public, including each
- 2 detention by a peace officer of a pedestrian; and
- 3 (B) collecting sufficient data to support a
- 4 multivariate analysis.
- 5 (b) Not later than January 1, 2027, the commission shall
- 6 report the study's findings and recommendations under Subsection
- 7 (a) to the governor, the lieutenant governor, the speaker of the
- 8 house of representatives, and each member of the legislature.
- 9 (c) This section expires September 1, 2027.
- 10 SECTION 3. This Act takes effect September 1, 2025.
