2	relating to the creation of the Fort Bend County Water Control and
3	Improvement District No. 13; granting a limited power of eminent
4	domain; providing authority to issue bonds; providing authority to
5	impose assessments, fees, and taxes.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle I, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 9095 to read as follows:
9	CHAPTER 9095. FORT BEND COUNTY WATER CONTROL AND IMPROVEMENT
10	DISTRICT NO. 13
11	SUBCHAPTER A. GENERAL PROVISIONS
12	Sec. 9095.0101. DEFINITIONS. In this chapter:
13	(1) "Board" means the district's board of directors.
14	(2) "Commission" means the Texas Commission on
15	Environmental Quality.
16	(3) "Director" means a board member.
17	(4) "District" means the Fort Bend County Water
18	Control and Improvement District No. 13.
19	Sec. 9095.0102. NATURE OF DISTRICT. The district is a water
20	control and improvement district created under Section 59, Article
21	XVI, Texas Constitution.
22	Sec. 9095.0103. CONFIRMATION AND DIRECTOR ELECTION
23	REQUIRED. The temporary directors shall hold an election to
24	confirm the creation of the district and to elect five permanent

- 1 directors as provided by Section 49.102, Water Code. 2 Sec. 9095.0104. CONSENT OF MUNICIPALITY REQUIRED. temporary directors may not hold an election under Section 3 9095.0103 until each municipality in whose corporate limits or 4 extraterritorial jurisdiction the district is located has 5 consented by ordinance or resolution to the creation of the 6 7 district and to the inclusion of land in the district as required by 8 applicable law. 9 Sec. 9095.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. 10 (a) The district is created to serve a public purpose and benefit. 11 (b) The district is created to accomplish the purposes of: 12 (1) a water control and improvement district as provided by general law and Section 59, Article XVI, Texas 13 Constitution, including the collection, transportation, 14 processing, disposal, and control of domestic, industrial, or 15 communal waste and the gathering, conducting, diverting, and 16 17 control of local storm water or other harmful excesses of water; and (2) Section 52, Article III, Texas Constitution, that 18 19 relate to the construction, acquisition, improvement, operation, or maintenance of macadamized, graveled, or paved roads, or 20 improvements, including storm drainage, in aid of those roads. 21 Sec. 9095.0106. INITIAL DISTRICT TERRITORY. (a) The 22 district is initially composed of the territory described by 23 24 Section 2 of the Act enacting this chapter. (b) The boundaries and field notes contained in Section 2 of 25
 - 2

the Act enacting this chapter form a closure. A mistake made in the

field notes or in copying the field notes in the legislative process

8	SUBCHAPTER B. BOARD OF DIRECTORS
9	Sec. 9095.0201. GOVERNING BODY; TERMS. (a) The district is
10	governed by a board of five elected directors.
11	(b) Except as provided by Section 9095.0202, directors
12	serve staggered four-year terms.
13	Sec. 9095.0202. TEMPORARY DIRECTORS. (a) The temporary
14	<pre>board consists of:</pre>
15	(1) Amanda Flynt;
16	(2) Jason Scholtz;
17	(3) Carlos Bujosa;
18	(4) Regina Landreneau; and
19	(5) Stephen Pheigaru.
20	(b) Temporary directors serve until the earlier of:
21	(1) the date permanent directors are elected under
22	Section 9095.0103; or
23	(2) the fourth anniversary of the effective date of
24	the Act enacting this chapter.
25	(c) If permanent directors have not been elected under
26	Section 9095.0103 and the terms of the temporary directors have
27	expired, successor temporary directors shall be appointed or

- 1 reappointed as provided by Subsection (d) to serve terms that
- 2 expire on the earlier of:
- 3 (1) the date permanent directors are elected under
- 4 Section 9095.0103; or
- 5 (2) the fourth anniversary of the date of the
- 6 appointment or reappointment.
- 7 (d) If Subsection (c) applies, the owner or owners of a
- 8 majority of the assessed value of the real property in the district
- 9 may submit a petition to the commission requesting that the
- 10 commission appoint as successor temporary directors the five
- 11 persons named in the petition. The commission shall appoint as
- 12 successor temporary directors the five persons named in the
- 13 petition.
- 14 SUBCHAPTER C. POWERS AND DUTIES
- Sec. 9095.0301. GENERAL POWERS AND DUTIES. The district
- 16 has the powers and duties necessary to accomplish the purposes for
- 17 which the district is created.
- 18 Sec. 9095.0302. WATER CONTROL AND IMPROVEMENT DISTRICT
- 19 POWERS AND DUTIES. The district has the powers and duties provided
- 20 by the general law of this state applicable to water control and
- 21 improvement districts created under Section 59, Article XVI, Texas
- 22 Constitution, including Chapters 49 and 51, Water Code, and
- 23 specifically including the powers and duties authorized under
- 24 Subchapter H, Chapter 51, Water Code.
- 25 Sec. 9095.0303. AUTHORITY FOR ROAD PROJECTS. Under Section
- 26 52, Article III, Texas Constitution, the district may design,
- 27 acquire, construct, finance, issue bonds for, improve, operate,

- 1 maintain, and convey to this state, a county, or a municipality for
- 2 operation and maintenance macadamized, graveled, or paved roads, or
- 3 improvements, including storm drainage, in aid of those roads.
- 4 Sec. 9095.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
- 5 road project must meet all applicable construction standards,
- 6 zoning and subdivision requirements, and regulations of each
- 7 municipality in whose corporate limits or extraterritorial
- 8 jurisdiction the road project is located.
- 9 (b) If a road project is not located in the corporate limits
- 10 or extraterritorial jurisdiction of a municipality, the road
- 11 project must meet all applicable construction standards,
- 12 subdivision requirements, and regulations of each county in which
- 13 the road project is located.
- 14 (c) If the state will maintain and operate the road, the
- 15 Texas Transportation Commission must approve the plans and
- 16 specifications of the road project.
- 17 Sec. 9095.0305. COMPLIANCE WITH MUNICIPAL CONSENT
- 18 ORDINANCE OR RESOLUTION. The district shall comply with all
- 19 applicable requirements of any ordinance or resolution that is
- 20 adopted under Section 42.042 or 42.0425, Local Government Code, and
- 21 consents to the creation of the district or to the inclusion of land
- 22 <u>in the district.</u>
- Sec. 9095.0306. LIMITATION ON USE OF EMINENT DOMAIN. The
- 24 district may not exercise the power of eminent domain outside the
- 25 district boundaries to acquire a site or easement for:
- 26 (1) a road project authorized by Section 9095.0303; or
- 27 (2) a recreational facility as defined by Section

1 49.462, Water Code. 2 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS Sec. 9095.0401. ELECTIONS REGARDING TAXES OR BONDS. (a) 3 The district may issue, without an election, bonds and other 4 5 obligations secured by: 6 (1) revenue other than ad valorem taxes; or 7 (2) contract payments described by Section 9095.0403. (b) The district must hold an election in the manner 8 provided by Chapters 49 and 51, Water Code, to obtain voter approval 9 10 before the district may impose an ad valorem tax or issue bonds payable from ad valorem taxes. 11 12 (c) The district may not issue bonds payable from ad valorem taxes to finance a road project unless the issuance is approved by a 13 vote of a two-thirds majority of the district voters voting at an 14 15 election held for that purpose. Sec. 9095.0402. OPERATION AND MAINTENANCE TAX. (a) 16 17 authorized at an election held under Section 9095.0401, the district may impose an operation and maintenance tax on taxable 18 19 property in the district in accordance with Section 49.107, Water Code. 20 21 (b) The board shall determine the tax rate. The rate may not 22 exceed the rate approved at the election. Sec. 9095.0403. CONTRACT TAXES. (a) In accordance with 23 24 Section 49.108, Water Code, the district may impose a tax other than

an operation and maintenance tax and use the revenue derived from

the tax to make payments under a contract after the provisions of

the contract have been approved by a majority of the district voters

- 2 (b) A contract approved by the district voters may contain a
- 3 provision stating that the contract may be modified or amended by
- 4 the board without further voter approval.
- 5 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- 6 Sec. 9095.0501. AUTHORITY TO ISSUE BONDS AND OTHER
- 7 OBLIGATIONS. The district may issue bonds or other obligations
- 8 payable wholly or partly from ad valorem taxes, impact fees,
- 9 revenue, contract payments, grants, or other district money, or any
- 10 combination of those sources, to pay for any authorized district
- 11 purpose.
- 12 Sec. 9095.0502. TAXES FOR BONDS. At the time the district
- 13 issues bonds payable wholly or partly from ad valorem taxes, the
- 14 board shall provide for the annual imposition of a continuing
- 15 direct ad valorem tax, without limit as to rate or amount, while all
- 16 or part of the bonds are outstanding as required and in the manner
- 17 provided by Chapter 51, Water Code.
- 18 Sec. 9095.0503. BONDS FOR ROAD PROJECTS. At the time of
- 19 issuance, the total principal amount of bonds or other obligations
- 20 issued or incurred to finance road projects and payable from ad
- 21 valorem taxes may not exceed one-fourth of the assessed value of the
- 22 real property in the district.
- Sec. 9095.0504. BONDS FOR RECREATIONAL FACILITIES. (a)
- 24 The district may develop recreational facilities and issue bonds
- 25 for recreational facilities as provided by Chapter 49, Water Code,
- 26 regardless of whether the district's territory overlaps with the
- 27 territory of a political subdivision that is authorized to develop

- 1 recreational facilities and issue bonds for recreational
- 2 <u>facilities under Chapter 49</u>, Water Code.
- 3 (b) The authority of the district to develop recreational
- 4 facilities and issue bonds for recreational facilities under this
- 5 section does not limit the authority of another political
- 6 subdivision whose territory the territory of the district may
- 7 overlap, wholly or partly, to develop recreational facilities and
- 8 <u>issue bonds for recreational facilities under Chapter 49, Water</u>
- 9 Code.
- 10 SECTION 2. The Fort Bend County Water Control and
- 11 Improvement District No. 13 initially includes all the territory
