- 26 improvements, including storm drainage, in aid of those roads.
- Sec. 8017A.0106. INITIAL DISTRICT TERRITORY. (a) The

district is initially composed of the territory described by 1 Section 2 of the Act enacting this chapter. 2 (b) The boundaries and field notes contained in Section 2 of 3 the Act enacting this chapter form a closure. A mistake made in the 4 5 field notes or in copying the field notes in the legislative process 6 does not affect the district's: 7 (1) organization, existence, or validity; 8 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 9 10 interest on a bond; (3) right to impose a tax; or 11 12 (4) legal<u>ity or operation.</u> SUBCHAPTER B. - Sec. 8017A.0301. GENERAL POWERS AND DUTIES. The district

- 17 SECTION 5. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2025.
