A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the election of the commissioners of the Jefferson
- 3 County Drainage District No. 7.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 4, Chapter 34, Acts of the 57th
- 6 Legislature, 3rd Called Session, 1962, is amended to read as
- 7 follows:
- 8 Sec. 4. The management and control of the District shall be
- 9 vested in five Commissioners. Except as provided by this Act, the
- 10 General Laws of the State of Texas relating to the Commissioners of
- 11 drainage districts shall apply to the Commissioners of the
- 12 District. The <u>District shall hold an election on the uniform</u>
- 13 <u>election date in November of each odd-numbered year to elect the</u>
- 14 appropriate number of Commissioners [are elected in accordance with
- 15 Subchapter D, Chapter 49, Water Code]. Not more than one
- 16 Commissioner shall be elected from any one municipality as long as
- 17 five municipalities exist within the district. Commissioners serve
- 18 staggered four-year terms. For all purposes, a quorum for doing
- 19 business shall consist of a majority of the Commission.
- 20 SECTION 2. (a) The Jefferson County Drainage District
- 21 No. 7 shall hold an election to elect two commissioners on the
- 22 uniform election date in November 2025, as provided by Section 4,
- 23 Chapter 34, Acts of the 57th Legislature, 3rd Called Session, 1962,
- 24 as amended by this Act.

- 1 (b) A commissioner serving on the board of commissioners of
- 2 the Jefferson County Drainage District No. 7 elected in May 2022
- 3 shall serve until the commissioner's successor has qualified
- 4 following the commissioners' election held on the uniform election
- 5 date in November 2025. A commissioner elected to succeed that
- 6 commissioner serves a four-year term.
- 7 (c) The Jefferson County Drainage District No. 7 shall hold
- 8 an election to elect three commissioners on the uniform election
- 9 date in November 2027, as provided by Section 4, Chapter 34, Acts of
- 10 the 57th Legislature, 3rd Called Session, 1962, as amended by this
- 11 Act.
- 12 (d) A commissioner serving on the board of commissioners of
- 13 the Jefferson County Drainage District No. 7 elected in May 2024
- 14 shall serve until the commissioner's successor has qualified
- 15 following the commissioners' election held on the uniform election
- 16 date in November 2027. A commissioner elected to succeed that
- 17 commissioner serves a four-year term.
- 18 SECTION 3. (a) The legal notice of the intention to
- 19 introduce this Act, setting forth the general substance of this
- 20 Act, has been published as provided by law, and the notice and a
- 21 copy of this Act have been furnished to all persons, agencies,
- 22 officials, or entities to which they are required to be furnished
- 23 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 24 Government Code.
- 25 (b) The governor, one of the required recipients, has
- 26 submitted the notice and Act to the Texas Commission on
- 27 Environmental Quality.

- 1 (c) The Texas Commission on Environmental Quality has filed
- 2 its recommendations relating to this Act with the governor, the
- 3 lieutenant governor, and the speaker of the house of
- 4 representatives within the required time.
- 5 (d) All requirements of the constitution and laws of this
- 6 state and the rules and procedures of the legislature with respect
- 7 to the notice, introduction, and passage of this Act are fulfilled
- 8 and accomplished.
- 9 SECTION 4. This Act takes effect September 1, 2025.
