

HOUSE CONCURRENT RESOLUTION

1       WHEREAS, The designation of September as Deaf Awareness Month  
2 serves as a fitting means to promote better understanding and to  
3 encourage greater support of individuals who are deaf or hard of  
4 hearing; and

5       WHEREAS, The International Day of the Deaf was first  
6 celebrated in 1958, and it later expanded to become a weeklong  
7 commemoration of the first World Congress of the World Federation  
8 of the Deaf, which took place in Rome in September 1951; Deaf  
9 Awareness Month was established in 1996 through the efforts of the  
10 National Association of the Deaf; in the years since, deaf and hard  
11 of hearing communities across the United States have marked the  
12 occasion by celebrating the essential role that its members play in  
13 society and by focusing attention on their experiences and  
14 achievements; and

15       WHEREAS, Texas is home to millions of individuals from  
16 diverse backgrounds who are deaf or hard of hearing, and the members  
17 of this unique cultural group share a rich and colorful history as  
18 well as deep social connections; they often communicate through  
19 visual methods, such as American Sign Language, written  
20 communication, and lipreading, and they may use technologies such  
21 as hearing aids, cochlear implants, video relay services, and  
22 closed captions; and

23       WHEREAS, Government agencies such as the Texas Health and  
24 Human Services Commission offer a variety of programs to support

1 citizens of all ages who are deaf or hard of hearing, including  
2 communication services for events, educational initiatives,  
3 interpreter training and certification, telecommunications  
4 assistance, and tuition waivers; moreover, advocates for the deaf  
5 and hard of hearing community are working to expand access to vital  
6 resources and assistance and are dedicated to reducing stigma  
7 related to deafness and hearing loss; and

8 WHEREAS, Deaf Awareness Month provides a welcome opportunity  
9 to educate the public about issues that impact Texans who are deaf  
10 or hard of hearing and to celebrate the many contributions they have  
11 made to the vibrancy and prosperity of the Lone Star State; now,  
12 therefore, be it

13 RESOLVED, That the 89th Legislature of the State of Texas  
14 hereby designate September as Deaf Awareness Month; and, be it  
15 further

16 RESOLVED, That, in accordance with the provisions of  
17 Section 391.004(d), Government Code, this designation remain in  
18 effect until the 10th anniversary of the date this resolution is  
19 finally passed by the legislature.
