CONCURRENT RESOLUTION

1 WHEREAS, Our nation was founded on the principle of popular 2 sovereignty, with a government of, by, and for the American people, and each generation has a responsibility to ensure that the promise 3 of self-government is open to all Americans; and 4 WHEREAS, The framers of the U.S. Constitution recognized the 5 peril of allowing outside influences to infiltrate our politics; 6 Article I, Section 9, Clause 8 of the Constitution forbids 7 officeholders from accepting any manner of title or financial 8 9 compensation from a foreign power; in The Federalist No. 68,

Alexander Hamilton warned of "the desire in foreign powers to gain 10

11 an improper ascendant in our councils," while, in his farewell

address, George Washington cautioned that "history and experience 12

prove that foreign influence is one of the most baneful foes of 13

republican government"; and WHEREAS, Through the years, Congress has passed a variety of 15 legislation to combat foreign interference, such as the Federal 16 Election Campaign Act, which includes a ban on spending by foreign 17 nationals in federal, state, and local elections; today, however, 18 our broken system of election spending makes it easy for foreign 19 entities to spend millions of dollars to influence our elections 20 21 and ballot initiatives, through such means as illegal donations directly to candidates, hidden contributions to dark money groups, 22 23 influence campaigns, and brazen spending in ballot elections by

1 WHEREAS, Decades of judicial overreach have also enabled domestic actors to drown out the voices of individual voters; 2 Supreme Court decisions degrading transparency and equating 3 unlimited election spending with "free speech" have 4 5 billionaires, corporations, unions, and other wealthy special interests to dominate and distort the public discourse, narrowing 6 debate, weakening federalism and state self-governance, 7 increasing the risk of systemic corruption; and 8

9 WHEREAS, Like the U.S. Constitution, the Constitution of 10 Texas affirms that political power rests with the people in our republican form of government; our continued liberty depends 11 heavily on protecting free speech interests of individual citizens 12 and maintaining the integrity of our elections and our government 13 14 in the face of outside pressures; and

WHEREAS, The framers wisely granted the states the power to amend the U.S. Constitution when necessary, and few issues are more 16 important than the preservation of the people's sovereign interests in robust political debate, the integrity of the electoral process, 18 19 open and representative self-government, and the political equality of natural persons; now, therefore, be it 20

21 RESOLVED, That the 89th Legislature of the State of Texas hereby respectfully urge the United States Congress to propose and 22 send to the states for ratification a constitutional amendment to 23 24 clarify that the states and Congress, within their respective jurisdictions, may reasonably regulate and limit the spending of 25 26 money to influence campaigns, elections, or ballot measures, and that, in so doing, the states and Congress may distinguish between 27

- 1 natural persons and artificial entities such as corporations,
- 2 unions, and artificial intelligences; and, be it further
- 3 RESOLVED, That the Texas secretary of state forward official
- 4 copies of this resolution to the president of the United States, to
- 5 the president of the Senate and the speaker of the House of
- 6 Representatives of the United States Congress, and to all the
- 7 members of the Texas delegation to Congress with the request that
- 8 this resolution be entered in the Congressional Record as a
- 9 memorial to the Congress of the United States of America.
