- 2 celebrated the dedication of its new building by Bishop Michael
- 3 J. Sis of the Diocese of San Angelo on March 16, 2024; and

- 16 Arcángel Parish in Midland, with Father Patrick Akpanobong as
- 17 pastor; community members worked tirelessly to raise funds for the
- 18 construction of their church, and they purchased a six-acre
- 19 property that includes the site of the earliest school in
- 20 Greenwood; they gathered for the ground breaking on September 17,
- 21 2022; deacon Bill Scarmardo served as architect and N. C. Sturgeon
- 22 was the general contractor; and
- 23 WHEREAS, The completion of this house of worship is a tribute
- 24 to the vision and perseverance of the St. Rita of Cascia community,
