A JOINT RESOLUTION

- 1 proposing a constitutional amendment to dedicate a portion of the
- 2 revenue derived from state sales and use taxes to the Texas water
- 3 fund.
- 4 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Article VIII, Texas Constitution, is amended by
- 6 adding Section 7-e to read as follows:
- 7 Sec. 7-e. (a) Subject to Section 7-d of this article and
- 8 Subsections (b) and (c) of this section, in each state fiscal year,
- 9 the comptroller of public accounts shall deposit to the credit of
- 10 the Texas water fund the net revenue derived from the imposition of
- 11 the state sales and use tax on the sale, storage, use, or other
- 12 consumption in this state of taxable items under Chapter 151, Tax
- 13 Code, or its successor, that exceeds the first \$48 billion of that
- 14 revenue coming into the treasury in that state fiscal year,
- 15 provided that the total amount deposited to the credit of the Texas
- 16 water fund under this subsection in a state fiscal year may not
- 17 exceed \$1 billion.
- 18 (b) The legislature by adoption of a concurrent resolution
- 19 approved by a record vote of two-thirds of the members of each house
- 20 of the legislature may direct the comptroller of public accounts to
- 21 increase or reduce the amount of money deposited to the credit of
- 22 the Texas water fund under Subsection (a) of this section. The
- 23 comptroller may be directed to make the increase or reduction only:
- 24 (1) in the state fiscal year in which the resolution is

- 1 adopted, or in either of the following two state fiscal years; and
- 2 (2) by an amount or percentage that does not result in:
- 3 (A) an increase of more than 100 percent of the
- 4 amount that would otherwise be deposited to the fund in the affected
- 5 state fiscal year under Subsection (a) of this section; or
- 6 (B) a reduction of more than 50 percent of the
- 7 amount that would otherwise be deposited to the fund in the affected
- 8 state fiscal year under Subsection (a) of this section.
- 9 (c) Subject to Subsection (d) of this section, the duty of
- 10 the comptroller of public accounts to make a deposit under this
- 11 section expires August 31, 2035.
- 12 (d) The legislature by adoption of a concurrent resolution
- 13 approved by a record vote of a majority of the members of each house
- 14 of the legislature may extend, in 10-year increments, the duty of
- 15 the comptroller of public accounts to make a deposit under
- 16 Subsection (a) of this section beyond the applicable date
- 17 prescribed by Subsection (c) of this section.
- 18 SECTION 2. The following temporary provision is added to
- 19 the Texas Constitution:
- TEMPORARY PROVISION. (a) This temporary provision applies
- 21 to the constitutional amendment proposed by the 89th Legislature,
- 22 Regular Session, 2025, to dedicate a portion of the revenue derived
- 23 from state sales and use taxes to the Texas water fund.
- 24 (b) Section 7-e, Article VIII, of this constitution takes
- 25 effect September 1, 2026.
- 26 (c) This temporary provision expires September 1, 2027.
- 27 SECTION 3. This proposed constitutional amendment shall be

- 1 submitted to the voters at an election to be held November 4, 2025.
- 2 The ballot shall be printed to permit voting for or against the
- 3 proposition: "The constitutional amendment to dedicate a portion of
- 4 the revenue derived from state sales and use taxes to the Texas
- 5 water fund."
