A JOINT RESOLUTION

1 proposing a constitutional amendment providing for the 2 establishment of the Alzheimer's Prevention and Research Institute 3 of Texas, establishing the Alzheimer's Prevention and Research Fund 4 to provide money for research on and prevention and treatment of 5 Alzheimer's disease and related disorders in this state, and 6 transferring to that fund \$3 billion from state general revenue.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Article III, Texas Constitution, is amended by

9 adding Section 68 to read as follows:

10Sec. 68. (a)The legislature shall establish the11Alzheimer's Prevention and Research Institute of Texas to:

12 <u>(1) award grants to institutions of learning, advanced</u> 13 medical research facilities, public or private persons, and 14 <u>collaboratives in this state to provide money for:</u>

15 (A) research into the causes of, means of 16 prevention of, and treatment and rehabilitation for Alzheimer's 17 disease and related disorders;

18 (B) research, including translational research, 19 to develop therapies, protocols, medical pharmaceuticals, or 20 procedures for the substantial mitigation of the symptoms of 21 Alzheimer's disease and related disorders;

22 (C) facilities, equipment, supplies, salaries, 23 benefits, and other costs related to research on Alzheimer's 24 disease and related disorders; and

1	(D) prevention programs and strategies to
2	mitigate the detrimental health impacts of Alzheimer's disease and

4	(2) support institutions of learning and advanced
5	medical research facilities and collaboratives in this state in all
6	stages of:
7	(A) discovering the causes of Alzheimer's
8	disease and related disorders;
9	(B) developing therapies, protocols, medical
10	pharmaceuticals, or procedures for the substantial mitigation of
11	the symptoms of Alzheimer's disease and related disorders from
12	laboratory research to clinical trials; and
13	(C) developing programs to address access to
14	advanced treatment for Alzheimer's disease and related disorders;
15	and
16	(3) establish the appropriate standards and oversight
17	bodies to ensure the proper use of funding authorized under this
18	section, including facilities development.
19	(b) The members of the governing body and any other
20	decision-making body of the Alzheimer's Prevention and Research
21	Institute of Texas may serve six-year terms.
22	(c) The Alzheimer's Prevention and Research Fund is
23	established as a special fund in the state treasury outside the
24	general revenue fund to be administered by the Alzheimer's
25	Prevention and Research Institute of Texas.
26	(c-1) On January 1, 2026, the comptroller shall transfer \$3
27	billion from this state's general revenue fund to the Alzheimer's

The transfer made under this 1 2 subsection is not an appropriation of state tax revenues for the purposes of Section 22, Article VIII, of this constitution. This 3 subsection expires January 1, 2029. 4 5 (d) The Alzheimer's Prevention and Research Fund consists of: 6 7 (1) money transferred to the fund under this section; 8 (2) money the legislature appropriates, credits, or transfers to the fund; 9 10 (3) gifts and grants, including grants from the federal government, and other donations received for the fund; 11 12 (4) patent, royalty, and license fees and other income received under a contract executed by the Alzheimer's Prevention 13 14 and Research Institute of Texas; and 15 (5) investment earnings and interest earned on amounts credited to the fund. 16 17 (e) Notwithstanding any other provision of this constitution, the Alzheimer's Prevention and Research Institute of 18 19 Texas, as established by general law, may use money in the Alzheimer's Prevention and Research Fund only for the purpose of 20 funding: 21 (1) grants for research on Alzheimer's disease and 22 related disorders, research facilities, and research opportunities 23 24 in this state: (A) for the prevention, treatment, and 25 26 rehabilitation of Alzheimer's disease and related disorders and the mitigation of the incidence of and detrimental health impacts from 27

1 the disease and disorders; and 2 (B) to develop therapies, protocols, medical pharmaceuticals, or procedures for the substantial mitigation of 3 the symptoms of Alzheimer's disease and related disorders; 4 (2) the purchase, construction, or renovation, 5 subject to the institute's approval, of facilities by or on behalf 6 7 of a state agency or grant recipient; and (3) the institute's operation. 8 9 (f) Before the Alzheimer's Prevention and Research 10 Institute of Texas may award a grant authorized under this section, the grant recipient must have available an unexpended amount of 11 12 money equal to one-half of the grant amount dedicated to the research specified in the grant proposal. 13 14 (g) The reasonable expenses of managing the assets of the 15 Alzheimer's Prevention and Research Fund shall be paid from the 16 fund.

17 SECTION 2. This proposed constitutional amendment shall be submitted to the voters at an election to be held November 4, 2025. 18 19 The ballot shall be printed to permit voting for or against the proposition: "The constitutional amendment providing for the 20 establishment of the Alzheimer's Prevention and Research Institute 21 of Texas, establishing the Alzheimer's Prevention and Research Fund 22 23 to provide money for research on and prevention and treatment of 24 Alzheimer's disease and related disorders in this state, and transferring to that fund \$3 billion from state general revenue." 25
