- 2 author, and documentary filmmaker specializing in the indigenous
- 3 foods of Texas and the Americas; and
- 4 WHEREAS, During long careers in broadcast journalism and
- 5 philanthropy, Mr. Medrano traveled widely and developed a deep
- 6 appreciation for the importance of food traditions to cultural
- 7 stability and sustainability; that became his focus, and he gained
- 8 experience as a chef in Houston and Belgium and graduated from the
- 9 Culinary Institute of America in 2010; he is known for coining the
- 10 term "Texas Mexican" to describe the cuisine he grew up with in San
- 11 Antonio, and The New York Times featured his cooking in a food
- 12 section cover story, "Don't Call It Tex-Mex!"; and
- WHEREAS, Mr. Medrano has authored two award-winning
- 14 cookbooks, Truly Texas Mexican: A Native Culinary Heritage in
- 15 Recipes and Don't Count the Tortillas: The Art of Texas Mexican
- 16 Cooking; published by Texas Tech University Press, they highlight
- 17 recipes used in many Mexican-Texan-American homes, rather than the
- 18 Tex-Mex cuisine developed in commercial kitchens; both are now part
- 19 of The University of Texas at San Antonio's renowned Mexican
- 20 Cookbook Collection, and UTSA Libraries Special Collections houses
- 21 his archival papers; and
- WHEREAS, A graduate of The University of Texas at Austin,
- 23 Mr. Medrano earned his master's degree in radio-television-film;
- 24 in the 1970s, he founded the trailblazing San Antonio CineFestival,

- 1 and he has long been active in television, film, and such
- 2 organizations as the Texas Commission on the Arts, the National
- Bendowment for the Arts, and the Museum of Fine Arts, Houston; he is
- 4 the executive producer and writer of the 2021 film Truly Texas
- 5 Mexican, which won Best Documentary at the New York Independent
- 6 Cinema Awards; in addition, he has lectured about food and culture
- 7 in academic settings, including Colorado College, the Culinary
- 8 Institute of America, and Northeastern University, and showcased
- 9 his recipes at restaurants and professional gatherings; and
- 10 WHEREAS, Through his wide-ranging endeavors, Adán Medrano
- 11 has raised awareness of a rich cultural heritage, delighting and
- 12 enlightening innumerable people in Texas and beyond; now,
- 13 therefore, be it
