13	ARTICLE 1. GENERAL PROVISIONS
14	SECTION 1.01. PURPOSE. This resolution is adopted by the
15	members of the House of Representatives of the <u>89th</u> [ <del>88th</del> ]
16	Legislature to provide for the efficient and orderly operation of
17	the house under the supervision of the speaker and the Committee or
18	House Administration.
19	SECTION 1.02. PRECEDENCE. The provisions of this
20	resolution take precedence over the provisions of any resolution
21	not passed in full compliance with the rules of the house and,
22	except as otherwise noted herein, shall be in effect during the full
23	term of the <u>89th</u> [ <del>88th</del> ] Legislature whether in session or
24	adjournment.
25	ARTICLE 2. SPEAKER OF THE HOUSE
26	SECTION 2.01. SPEAKER'S GENERAL POWERS AND DUTIES. The
27	speaker may make any expenditures or transfers and perform any

- 1 function deemed necessary for the effective and efficient operation
- 2 of the house of representatives.
- 3 SECTION 2.02. SPEAKER'S APARTMENT AND OFFICES. (a) The
- 4 speaker's apartment and offices shall be set aside for the use of
- 5 the speaker, the speaker's family, and house members, as the
- 6 speaker may designate, throughout the speaker's term of office.
- 7 (b) The Committee on House Administration may make the
- 8 necessary expenditures to operate and properly equip and service
- 9 the speaker's apartment and offices and may employ such help as may
- 10 be necessary to properly maintain and care for the apartment and
- 11 offices.
- 12 (c) The speaker and the speaker's family may occupy the
- 13 speaker's apartment during the speaker's term of office, utilizing
- 14 the services of employees of the house and others on a temporary
- 15 basis, if and as needed.
- 16 (d) The speaker may obtain through the Committee on House
- 17 Administration the necessary supplies and services to operate the
- 18 speaker's office and may also have paid through that committee
- 19 necessary telephone charges.
- 20 SECTION 2.03. INTERSTATE OR FEDERAL-STATE ASSOCIATIONS;
- 21 TRAINING SEMINARS. (a) The speaker may attend any meetings of or
- 22 sponsored by the Council of State Governments and any meetings on
- 23 problems of federal-state relations and interstate relations and
- 24 cooperation, and any other governmental meeting in or outside the
- 25 state.
- 26 (b) The speaker may appoint members of the house, staff
- 27 members, and other employees of the house to accompany or represent

- 1 the speaker at these meetings or to attend in-service training
- 2 courses sponsored by the Council of State Governments or the
- 3 National Conference of State Legislatures or similar training
- 4 courses, conferences, or seminars as the speaker may determine.
- 5 Members of the house attending meetings under this section while the legislature is in session may be reimbursed for 6 actual and necessary expenses. Members of the house attending 7 8 meetings under this section while the legislature is not in session and staff members and other employees of the house attending 9 10 meetings at any time under this section may be reimbursed for either actual and necessary expenses or receive a per diem not to exceed 11 that provided by law for state officials or state employees. 12 addition, members, staff, and other employees attending meetings 13 under this section may be reimbursed for mileage or other 14 15 transportation expenses at the same rate as provided by law for state officials or state employees together with registration fees 16 17 and tuition. To receive payment under this subsection, sworn expense accounts must be filed with and approved by the chair of the 18 Committee on House Administration or an officer of the house 19 designated in writing by the Committee on House Administration. 20 21 Prior written approval of the chair of the Committee on House Administration to attend any such meetings, conferences, seminars, 22 23 or training courses is a prerequisite for reimbursement for travel 24 and other related expenses.
- (d) Reimbursement for expenses incurred by a member, staff member, or employee of the house in an appointive capacity resulting from an appointment made by anyone other than the speaker

- 1 shall be made only in the event that the appointment and expenses to
- 2 be incurred have been previously approved in writing by the
- 3 Committee on House Administration.
- 4 (e) The speaker may expend money for memberships in
- 5 interstate associations of legislators considered necessary to
- 6 discharge properly the duties and responsibilities of the office of
- 7 speaker.
- 8 SECTION 2.04. DEANS. The speaker shall recognize as deans
- 9 both the male member and the female member having the greatest
- 10 seniority based on cumulative years of service in the house.
- 11 ARTICLE 3. GENERAL POWERS AND DUTIES OF THE COMMITTEE ON HOUSE
- 12 ADMINISTRATION
- 13 SECTION 3.01. CONTRACTS. The Committee on House
- 14 Administration shall approve all contracts necessary for the
- 15 effective operation of the divisions of the house and its
- 16 committees.
- 17 SECTION 3.02. HOUSE AND COMMITTEE OPERATING BUDGETS. The
- 18 Committee on House Administration shall consider and adopt
- 19 operating budgets that cover both session and interim periods for
- 20 the divisions of the house and all committees appointed pursuant to
- 21 the resolution adopting the rules of the house or appointed by the
- 22 speaker pursuant to any other resolution. A budget adopted by the
- 23 Committee on House Administration must be adopted in a public
- 24 hearing. Each requested operating budget and each operating budget
- 25 proposed for adoption must be posted on the Internet website of the
- 26 committee in advance of the hearing.
- 27 SECTION 3.03. OPERATING POLICIES. The Committee on House

- 1 Administration shall effectuate policies and determine guidelines
- 2 for the operation of the divisions and committees of the house.
- 3 SECTION 3.04. HOUSE POLICY MANUAL. The Committee on House
- 4 Administration shall prepare and distribute to all members, within
- 5 60 days after the convening of the regular session, policy
- 6 statements to include, but not be limited to, policies pertaining
- 7 to members as a class.
- 8 SECTION 3.05. HOUSE PROPERTY, SUPPLIES, ACCOUNTING. The
- 9 Committee on House Administration shall:
- 10 (1) provide and maintain for the use of the speaker,
- 11 members, employees, divisions, and committees of the house such
- 12 stationery, stamps, office equipment, furniture, fixtures,
- 13 supplies, and telephone and other services as may be necessary;
- 14 (2) keep an itemized account of the quantity and cost
- 15 of every kind of material received, and the source from which it was
- 16 received;
- 17 (3) maintain an annual operating account for each
- 18 member, division, and committee authorized by the Committee on
- 19 House Administration to make expenditures and charge each operating
- 20 account with daily expenditures, withdrawals from inventory, and
- 21 interdepartmental services;
- 22 (4) furnish a monthly statement for the expenditures
- 23 of each member, division, and committee of the house; and
- 24 (5) adopt any rules, regulations, and policies
- 25 necessary to effectively provide and account for the
- 26 above-mentioned services.
- 27 SECTION 3.06. USE OF HOUSE CHAMBER AND FACILITIES;

- 1 ASSIGNMENT OF DESKS, OFFICES, AND PARKING SPACES. (a) The
- 2 Committee on House Administration shall:
- 3 (1) be in charge of and provide for the protection,
- 4 maintenance, and use of the hall of the house, all committee rooms,
- 5 offices of members and house departments, the speaker's office and
- 6 apartment, and other space under the jurisdiction of the house;
- 7 (2) make permanent assignments of desks and offices to
- 8 members of the house;
- 9 (3) adopt and enforce a plan for the parking of motor
- 10 vehicles on the portion of the Capitol grounds under house
- 11 jurisdiction;
- 12 (4) be in charge of and provide for the protection,
- 13 maintenance, and use of the furniture, fixtures, equipment, and
- 14 records of the house;
- 15 (5) purchase, remodel, repair, restore, or replace any
- 16 furniture, fixtures, equipment, and other furnishings to maintain
- 17 the dignity and appearance of space occupied by the house;
- 18 (6) in consultation with the State Preservation Board,
- 19 identify and establish a space that provides privacy, security, a
- 20 water faucet, and a power outlet, within or near the hall of the
- 21 house for use for breastfeeding or breast pumping by house members
- 22 and employees of the house or media representatives entitled to the
- 23 privileges of the floor when the house is in session; and
- 24 (7) determine the hours the hall of the house shall be
- 25 open to visitors.
- 26 (b) Any member who is not a member-elect of the 90th [89th]
- 27 Legislature shall vacate the member's office space before December

- 1 1, 2026 [2024]. If the office is not vacated on that date, the
- 2 Committee on House Administration shall immediately remove the
- 3 member's personal effects and store them in an appropriate place in
- 4 order that the member-elect to whom the office space is assigned may
- 5 move in. The Committee on House Administration shall ensure that
- 6 each member-elect of the 90th [89th] Legislature who was not a
- 7 member of the <u>89th</u> [<del>88th</del>] Legislature is permitted to move into and
- 8 begin using the member-elect's office space at least 72 hours
- 9 before the time the 90th [89th] Legislature is scheduled to
- 10 convene.
- 11 SECTION 3.07. RECORDS OF THE HOUSE; PRINTING; JOURNALS;
- 12 COPIES OF LEGISLATIVE DOCUMENTS. (a) The Committee on House
- 13 Administration shall:
- 14 (1) have completed and preserved the official records
- 15 of the house;
- 16 (2) have charge of and approve the operation and
- 17 maintenance of the printing and duplicating facilities of the
- 18 house, provided, however, that the use of the house printing and
- 19 duplicating facilities is restricted to agencies of the legislative
- 20 branch and any other operation thereof is strictly prohibited
- 21 unless previously authorized in writing by the Committee on House
- 22 Administration or an officer of the house designated in writing by
- 23 the speaker;
- 24 (3) determine the number of copies of the daily House
- 25 Journal to be printed and have jurisdiction over the mailing and
- 26 distribution of the daily journal; and
- 27 (4) determine the number of copies of the House

- 1 Journal that will be furnished to each member for distribution by
- 2 the member.
- 3 (b) The employee in charge of the printing facilities must
- 4 keep at least one copy of all items printed or duplicated and a copy
- 5 of the work order authorizing such printing.
- 6 (c) Copies of bills, resolutions, and attachments thereto
- 7 shall be made available free of charge to members of the house who
- 8 call at the bill distribution office and request them, and the cost
- 9 of these copies shall be paid from funds appropriated for that
- 10 purpose by the legislature. If the Committee on House
- 11 Administration finds gross abuse of this privilege, it may
- 12 establish a policy regarding such distribution.
- 13 SECTION 3.08. HONORARY CERTIFICATES. The Committee on
- 14 House Administration shall provide for the use of members
- 15 appropriate certificates to commend, congratulate, and
- 16 memorialize. Such certificates shall be printed with a signature
- 17 line for the name of the presenting member and adequate space for
- 18 insertion of the name of the individual or organization to be
- 19 honored.
- 20 SECTION 3.09. COMPOSITE PHOTOGRAPH. (a) The Committee on
- 21 House Administration shall select a suitable photographer to take
- 22 individual photographs of each member. The photographer shall
- 23 prepare a composite photograph of the members of the house composed
- 24 of the individual photographs of each member arranged on a panel, of
- 25 the same size as used in previous sessions, in such manner as to
- 26 approximate the location of each member's desk on the house floor.
- 27 The member's name and the county of residence shall be printed under

- 1 the member's photograph, and the composite shall be framed and hung
- 2 in the hall of the house during the regular session.
- 3 (b) The photographs for the composite panel shall be
- 4 provided without cost to the members, and the expense of the
- 5 composite panel shall be paid from the expense fund of the house.
- 6 (c) The Committee on House Administration shall establish,
- 7 with concurrence of the photographer, a price to charge members for
- 8 any prints of photographs they wish to purchase.
- 9 SECTION 3.10. POLICIES REGARDING TEMPORARY ACTING MEMBERS.
- 10 If a person is serving as a temporary acting member of the house
- 11 under Section 72, Article XVI, Texas Constitution, in the place of a
- 12 house member on active military duty, the Committee on House
- 13 Administration, with the approval of the speaker and in
- 14 consultation with the temporary acting member and, if available,
- 15 the member on military duty, may adopt policies regarding a
- 16 temporary acting member that the committee considers necessary for
- 17 the efficient administration and performance of the duties of the
- 18 house consistent with this resolution, the rules of the house, and
- 19 the Texas Constitution.
- 20 SECTION 3.11. DISPLAY OF "IN GOD WE TRUST" IN HOUSE. The
- 21 Committee on House Administration shall direct the State
- 22 Preservation Board to maintain the permanent display of the motto
- 23 "In God We Trust" on the face of the portico located over the
- 24 speaker's podium.
- 25 SECTION 3.115. DISPLAY OF TEN COMMANDMENTS IN HOUSE. The
- 26 Committee on House Administration shall direct the State
- 27 Preservation Board to permanently display the Ten Commandments in

- 1 the house chamber in a manner that is prominent and visible from all
- 2 angles to members of the house from the house floor and to the
- 3 public from the house gallery.
- 4 SECTION 3.12. HOUSE RECYCLING PROGRAM. The Committee on
- 5 House Administration, in coordination with the State Preservation
- 6 Board, shall implement a program for recycling paper, plastic, and
- 7 other recyclable materials from house offices.
- 8 SECTION 3.13. JOINT COMMITTEE HEARING NOTICES ON WEBSITE.
- 9 The Committee on House Administration shall provide for the posting
- 10 of all notices for hearings of joint committees of the house and
- 11 senate on the house website regardless of whether the notice is
- 12 posted on the senate website.
- 13 SECTION 3.14. ACCESS TO HOUSE OFFICES. A house member and
- 14 the member's staff may control access by the public to the member's
- 15 office and may exclude visitors from the office at their
- 16 discretion. If a person refuses to leave the member's office when
- 17 requested, the member may request assistance from the Department of
- 18 Public Safety.
- 19 SECTION 3.15. DPS PANIC BUTTONS. The Committee on House
- 20 Administration shall work with the Department of Public Safety to
- 21 ensure that each house office may request a panic button that the
- 22 house member and the member's staff may use to alert the department
- 23 to an emergency in the office. The member may reimburse the
- 24 Committee on House Administration for the cost of the panic button
- 25 equipment in monthly installments over the fiscal year.
- 26 SECTION 3.16. USE OF HOUSE AUDIO OR VIDEO RESOURCES. The
- 27 Committee on House Administration shall adopt a policy that allows

- 1 members the use of house audio or visual resources. Use of house
- 2 audio or visual resources may only be prohibited for the following
- 3 reasons:
- 4 (1) the use is otherwise prohibited by law;
- 5 (2) the use maligns the reputation of an individual;
- 6 or
- 7 (3) the use is for political advertising, as defined
- 8 by Section 251.001, Election Code.
- 9 SECTION 3.17. MULTI-USE RESTROOM POLICY. (a) The
- 10 Committee on House Administration shall adopt a policy limiting
- 11 access to each multi-use restroom under the jurisdiction of the
- 12 house to persons of the same biological sex as that term is used in
- 13 Section 33.0834, Education Code.
- 14 (b) The Committee on House Administration shall exempt the
- 15 following individuals from the policy adopted under Subsection (a)
- 16 of this section:
- 17 (1) a person entering a multi-use restroom:
- 18 (A) for a bona fide custodial or maintenance
- 19 purpose;
- 20 (B) to render medical or other emergency
- 21 <u>assistance;</u>
- (C) to accompany a person needing assistance in
- 23 <u>using the facility; or</u>
- 24 (D) to receive assistance in using the facility;
- (2) a child who is younger than 10 years of age who is
- 26 accompanied by a person caring for the child.

- 11 (e) A member who is the chair of a committee may not transfer 12 and have credited to that member's operating account any portion of 13 the unexpended balance of the committee's operating account.
- SECTION 5.06. EXPENDITURES CHARGED WHEN ENCUMBERED. All expenditures shall be charged to the period in which they are encumbered.
- SECTION 5.07. TRAVEL FROM AUSTIN DURING SESSION NOT CHARGED
  TO OPERATING ACCOUNT. While the legislature is in session, the
  travel expenses of members for one trip each week between Austin and
  their districts and return shall not be charged against the
  members' operating accounts but shall be paid from funds
  appropriated for that purpose by the legislature.
- SECTION 5.08. TRAVEL OUTSIDE TEXAS. A member is entitled to be reimbursed for actual and necessary expenses incurred while traveling outside Texas in the performance of legislative duties and responsibilities. If the reimbursement is for travel inside the conterminous United States, reimbursement is limited to twice

- 1 the amount that would be reimbursed to state employees for the same
- 2 travel under the comptroller's guidelines and rates governing

- 4 SECTION 5.09. APPROVAL OF EXPENDITURES. (a) No allowance

- 1 use or direct the use of any house resources to further any

- 24 interests that the membership holds in common. An organization

- 27 SECTION 6.02. USE OF HOUSE FUNDS, EMPLOYEES, EQUIPMENT, AND

- 1 FACILITIES. (a) Except as expressly authorized by this section,
- 2 funds appropriated to the house may not be expended in support of a
- 3 caucus, employees compensated from funds appropriated to the house
- 4 may not perform caucus activities, and state-owned equipment may
- 5 not be used in the performance of caucus activities.
- 6 (b) An individual member of the house may authorize the use
- 7 of state equipment assigned to the member's office and the
- 8 performance of caucus activities by an employee of the member only
- 9 if:
- 10 (1) the member determines that the activities support
- 11 the member's official duties;
- 12 (2) the caucus does not endorse or support a candidate
- 13 for public office; and
- 14 (3) the caucus does not accept contributions from
- 15 nonmembers that are in violation of Section 253.0341, Election

- 17 (c) A caucus may use the meeting rooms of the Capitol and
- 18 Capitol extension to conduct meetings of the caucus membership, to
- 19 host public forums on matters of interest to the caucus, or to
- 20 facilitate the work of the caucus or a caucus employee.
- 21 (d) An individual member may house, in the state office
- 22 space assigned to the member, caucus employees or equipment owned
- 23 by a caucus. A member may retain in the member's office a
- 24 telephone, facsimile machine, or computer owned by the caucus for
- 25 purposes of the member's communication with the caucus or caucus
- 26 employees.
- (e) From space under the jurisdiction of the house, the

- 1 Committee on House Administration may assign:
- 2 (1) one office space and one parking space for use by
- 3 the Texas Republican Legislative Caucus; and
- 4 (2) one office space and one parking space for use by
- 5 the House Democratic Caucus.
- 6 SECTION 6.03. CONTRIBUTIONS. (a) A person acting on behalf
- 7 of a caucus may not knowingly accept a contribution in violation of
- 8 Section 253.0341, Election Code.
- 9 (b) A person acting on behalf of a caucus may not knowingly
- 10 accept a contribution, and shall refuse a contribution that is
- 11 received, in the Capitol.
- 12 SECTION 6.04. MEMBERSHIP AND OFFICER LISTS. Each caucus
- 13 shall provide to the chief clerk, on a regular basis, a list of its
- 14 current membership and officers.
- 15 SECTION 6.05. REPORT TO ETHICS COMMISSION. Each caucus
- 16 shall file a report of contributions and expenditures with the
- 17 Texas Ethics Commission as required by Section 254.0311, Election
- 18 Code.
- 19 ARTICLE 7. HOUSE RESEARCH ORGANIZATION
- 20 SECTION 7.01. ESTABLISHMENT. The Committee on House
- 21 Administration shall provide operating funds for a house research
- 22 organization that will be an administrative department of the house
- 23 and may for that purpose adopt policies and procedures relating to
- 24 the administrative operation of that organization.
- 25 SECTION 7.02. STEERING COMMITTEE. The functions and duties
- 26 performed by the house research organization shall be governed by a
- 27 15-member steering committee composed of house members serving

- 1 staggered four-year terms, who are subject to approval of the house
- 2 membership.
- 3 SECTION 7.03. BUDGET. The house research organization
- 4 shall have an operating account and in compliance with the terms of
- 5 its establishment shall operate under a budget approved by the
- 6 steering committee and the Committee on House Administration.
- 7 ARTICLE 8. SPECIAL PROVISIONS FOR INTERIM
- 8 SECTION 8.01. INTERIM COMMITTEE ACTIVITIES. (a) Pursuant
- 9 to the Legislative Reorganization Act of 1961 (Subchapter B,
- 10 Chapter 301, Government Code), standing committees of the house
- 11 established by the rules of the house may hold meetings while the
- 12 legislature is not in session.
- 13 (b) The speaker may grant authority to select committees,
- 14 interim study committees, subcommittees, or standing committees of
- 15 the house to hold meetings while the legislature is not in session
- 16 as the speaker considers necessary and desirable to conduct the
- 17 business of the house and to assist the speaker in conducting the
- 18 business of the house, under a pattern of operation and
- 19 restrictions determined by the rules of the house.
- 20 (c) The committee members and employees may either be
- 21 reimbursed for actual and necessary expenses or receive a per diem
- 22 not to exceed that provided by law for state officials or state
- 23 employees, along with mileage or other transportation expenses at
- 24 the same rate as provided by law for state officials or state
- 25 employees when conducting such business and attending those
- 26 meetings when approved by the Committee on House Administration.
- 27 SECTION 8.02. POWERS AND DUTIES OF COMMITTEE ON HOUSE

- 1 ADMINISTRATION DURING INTERIM. (a) When the legislature is not in
- 2 session, the Committee on House Administration may act as provided
- 3 by this section.
- 4 (b) The committee may call meetings for the transaction of
- 5 necessary business, and the committee members shall be reimbursed
- 6 for expenses incurred by them when attending such meetings or when
- 7 in performance of their duties as members of the Committee on House
- 8 Administration, the reimbursement to be either actual and necessary
- 9 expenses or a per diem not to exceed that provided by law for state
- 10 officials or state employees, along with mileage or other
- 11 transportation expenses at the same rate as provided by law for
- 12 state officials or state employees.
- 13 (c) The committee may reimburse authorized members and
- 14 employees for expenses incurred by them when traveling in the
- 15 performance of their legislative duties and responsibilities
- 16 within their respective districts or within any county in which any
- 17 part of their districts lie or from their districts to the State
- 18 Capitol, the reimbursement to be either actual and necessary
- 19 expenses or a per diem not to exceed that provided by law for state
- 20 officials or state employees, along with mileage or other
- 21 transportation expenses at the same rate as provided by law for
- 22 state officials or state employees.
- 23 (d) The committee may pay for all other reasonable and
- 24 necessary expenses, including operation of each member's district
- 25 office, incurred by the members of the house of representatives.
- 26 The expenses shall be paid from funds appropriated for that
- 27 purpose, or any other funds appropriated for the use of the house of

- 1 representatives, on vouchers or other forms approved by the chair
- 2 of the Committee on House Administration, in accordance with
- 3 regulations governing such expenditures.
- 4 (e) The committee may assign or reassign parking places in
- 5 the best interest of the house under such terms and conditions as
- 6 the committee deems necessary.
- 7 ARTICLE 9. APPROPRIATE WORKPLACE CONDUCT
- 8 SECTION 9.01. PURPOSE. (a) The house finds that early
- 9 intervention is often the most effective way to resolve incidents
- 10 of inappropriate behavior and ensure appropriate workplace
- 11 conduct.
- 12 (b) The house encourages the prompt reporting of concerns
- 13 and complaints, as appropriate, so that constructive action can be
- 14 taken before the offensive conduct continues, escalates, or affects
- 15 others, and to ensure that a timely and thorough investigation can
- 16 occur if necessary.
- 17 (c) This article is adopted to further early intervention
- 18 and remediation of complaints and implements the house rules.
- 19 SECTION 9.02. TRAINING. (a) Each member, officer, and
- 20 employee is required to complete an interactive training program
- 21 related to preventing and resolving violations of the house rules,
- 22 this resolution, and house policy related to appropriate workplace
- 23 conduct that is approved every two years by the Committee on House
- 24 Administration. This training may be combined with training on
- 25 other employment-related topics such as employment discrimination
- 26 and workplace violence.
- 27 (b) The training must include specific information related

- 1 to the process for reporting violations of a house rule, this
- 2 resolution, and house policy related to appropriate workplace
- 3 conduct, for utilizing informal methods of resolving those
- 4 violations, and for filing formal complaints with the house or
- 5 another agency designated by law to receive those complaints.
- 6 (c) The training required by this section must be completed 7 not later than the 30th day after:
- 8 (1) the member qualifies;
- 9 (2) the officer is appointed; or
- 10 (3) the employee starts employment.
- 11 (d) A member, officer, or employee is required to complete a
- 12 subsequent approved interactive training program not later than
- 13 each biennial anniversary of the date the individual was initially
- 14 required to complete the training under Subsection (c) of this
- 15 section.
- 16 (e) The Committee on House Administration shall designate
- 17 an officer or supervisory administrative employee to keep accurate
- 18 records of each individual required to complete an approved
- 19 training program. The officer or employee shall make those records
- 20 available to the public.
- 21 SECTION 9.03. COMPLAINTS; FILING, INVESTIGATION, AND
- 22 RESOLUTION. (a) An individual claiming to be aggrieved by a
- 23 violation of the house rules, this resolution, or house policy
- 24 related to appropriate workplace conduct may file a complaint with:
- 25 (1) the chair of the house general investigating
- 26 committee established under Section 301.017, Government Code, if
- 27 the individual whose complained-of conduct is an individual other

- 1 than the chair, the chair's employee, or an individual related to
- 2 the chair or the chair's employee within the third degree by
- 3 consanguinity or within the second degree by affinity as determined
- 4 under Chapter 573, Government Code; or
- 5 (2) the vice chair of the committee, if the individual
- 6 whose complained-of conduct is the chair of the committee, the
- 7 chair's employee, or an individual related to the chair or the
- 8 chair's employee within the third degree by consanguinity or within
- 9 the second degree by affinity as determined under Chapter 573,
- 10 Government Code.
- 11 (b) Any complaint must be substantially similar in form to
- 12 the requirements of Sections 21.201(b) and (c), Labor Code.
- 13 (c) Upon receipt of a complaint that meets the requirements
- 14 of Subsection (b) of this section, the receiving official may, with
- 15 the agreement of the parties, endeavor to address the alleged
- 16 violation by informal, voluntary, and confidential methods of
- 17 conference and conciliation.
- 18 (d) During the pendency of a complaint, the committee may
- 19 take any appropriate action to reduce the likelihood of a
- 20 complainant and respondent being in regular contact with each
- 21 other.
- (e) The committee shall conduct an investigation of a
- 23 complaint, determine whether reasonable cause exists to believe
- 24 that the respondent violated a house rule, this resolution, or
- 25 house policy, and attempt to resolve the complaint through informal
- 26 or formal methods, as provided by committee rule. The committee's
- 27 rules must provide for a process substantially similar to the

- 1 process provided for the administrative review of complaints under
- 2 Subchapter E, Chapter 21, Labor Code, where applicable, and must
- 3 include a due process hearing by the committee before a report is
- 4 prepared under Subsection (h) of this section.
- 5 (f) If the respondent is a member of the house, the
- 6 committee's investigation must be conducted by a competent
- 7 individual who is not an officer, employee, or annuitant of state
- 8 government. The prohibition under this subsection does not apply
- 9 to a retired or former judge subject to assignment under Subchapter
- 10 C, Chapter 74, Government Code.
- 11 (g) The individual employed or compensated by the committee
- 12 under Subsection (f) of this section shall only perform the
- 13 investigative functions of determining facts and reporting those
- 14 facts to the committee and shall not perform any other functions
- 15 for, or provide other services to, the committee in connection with
- 16 a complaint.
- 17 (h) If the committee cannot resolve the complaint, the
- 18 committee shall determine whether the respondent violated a house
- 19 rule, this resolution, or house policy as alleged in a complaint and
- 20 shall prepare a report containing:
- 21 (1) the committee's findings of fact and conclusions
- 22 of law to support its final determination; and
- 23 (2) if the committee finds that the respondent
- 24 violated a house rule, this resolution, or house policy, a
- 25 recommendation for any discipline or remedial action, in proportion
- 26 to the seriousness of the conduct, necessary to prevent the
- 27 violation from occurring again.

- No committee report shall be made unless ordered by 1 two-thirds of the membership of the committee. If a committee 2 report is ordered, any member of the committee dissenting from the 3 views of the majority may file a minority report, which is not 4 5 subject to House Rule 4, Section 28. The minority report shall be included with the majority report at each distribution. 6 committee is unable to agree on a recommendation for action or has 7 an insufficient number of votes to adopt the report prepared by the 8 committee, it shall submit a statement of this fact as its report. 9 10 The committee shall deliver a copy of its report to the complainant and respondent and, if the respondent is: 11
- 12 (1) a member of the house, to the speaker and the chief 13 clerk;
- 14 (2) an officer of the house, to the speaker; and
- 15 (3) an employee of the house, to the employee's 16 employing authority as set out in this resolution.
- 17 All proceedings on a complaint are completely confidential, and information related to those proceedings may not 18 be released by any person unless authorized by committee rule or by 19 the house. Notices of committee hearings, minutes, and witness 20 lists required under the house rules shall be prepared as directed 21 by the Committee on House Administration to ensure that no 22 information is provided that would reasonably lead to the 23 24 identification of a complainant, respondent, or witness. individual releases information made confidential by this section 25 26 without authorization, that individual is subject to sanction by 27 the house as authorized by Section 15, Article III,

- 1 Constitution, or other law. Any report of the house general
- 2 investigating committee under this section is confidential until it
- 3 is ordered printed by the house or ordered released by the committee
- 4 if the house is not in session.
- 5 (k) To the extent of any conflict between this section and
- 6 Rule 4 of the House Rules, this section prevails.
- 7 <u>SECTION 9.04. PROHIBITION ON POSSESSION, DISTRIBUTION, OR</u>
- 8 CONSUMPTION OF ALCOHOLIC BEVERAGES IN CERTAIN PLACES. No person
- 9 may possess, distribute, or consume any alcoholic beverage, as
- 10 defined by Section 1.04, Alcoholic Beverage Code, in any space
- 11 under the jurisdiction of the house other than:
- 12 (a) the speaker's apartment;
- 13 (b) the speaker's office; or
- 14 (c) an office of a member of the house.
- 15 ARTICLE 10. COMMITTEE GIFTS
- 16 [SECTION 10.01. COMMITTEE GIFTS. (a) Subject to the
- 17 limitation in Subsection (b) of this section, a member of the house
- 18 may not offer, confer, or agree to confer to a committee member one
- 19 or more gifts per year with a total value of more than the amount of
- 20 the per diem set by the Texas Ethics Commission pursuant to Section
- 21 24a(e), Article III, Texas Constitution.
- (b) If two or more members of the house join together to
- 23 offer, confer, or agree to confer to a committee chair or vice chair
- 24 one or more gifts per year, the total value of the gifts may not
- 25 exceed three times the amount of the per diem described in
- 26 Subsection (a) of this section.
- 27 SECTION 10.02. USE OF COMMITTEE FUNDS PROHIBITED. No

- 1 committee funds shall be spent on committee gifts for members or
- 2 otherwise.
- 3 ARTICLE 11. CONFLICTING PROVISIONS
- 4 SECTION 11.01. CONFLICTING PROVISIONS. In the event of any
- 5 conflict between any provision of this resolution and any other
- 6 motion, resolution, or amendment subsequently adopted by the house,
- 7 the subsequently adopted motion, resolution, or amendment
- 8 <u>controls.</u>
