1 WHEREAS, Family and friends were deeply saddened by the
2 passing of Mary Winifred Weingarth Newton on December 21, 2024, at
3 the age of 85; and

4 WHEREAS, The daughter of Frederick Charles Weingarth II and
5 Agnes Jelinek Weingarth, the former Mary Weingarth was born in
6 Kansas City, Missouri, on October 20, 1939, and she grew up with the
7 companionship of a brother, Frederick; after graduating from
8 Littleton High School in Colorado in 1957, she earned a bachelor's
9 degree in business education from Colorado State College; and

10 WHEREAS, While attending college, she met Ronald James
11 Newton, and the couple married in 1961; she took great pride in her
12 children, Courtney and Brooke, and over the years, she had the
13 pleasure of seeing her family grow to include four grandchildren,
14 Taylor, Grace, Sam, and Hazel; and

16 education, teaching at schools in Colorado, California, and
