3 WHEREAS, The roots of Methodist Healthcare Ministries trace back to 1955, when the Southwest Conference of The United Methodist 4 5 Church approved the formation of a nonprofit to own and operate hospitals in the name of the church; opening in 1963, the Southwest 6 7 Methodist Hospital sought to promote and deliver accessible, quality health care to the underserved, and Methodist Healthcare 8 Ministries has continued to advance this mission since 9 establishment in 1995; today, the Methodist Healthcare System 10 11 serves as the largest health care provider in San Antonio and 26 surrounding counties and oversees operations 12 at numerous specialized area hospitals; and 13

14 WHEREAS, Methodist Healthcare Ministries offers primary medical and dental care as well as counseling, case management, 15 16 social services, family wellness, and church-based community nursing programs to patients across 74 counties; the nonprofit 17 organization also oversees grant-making and policy initiatives, 18 and it has worked with more than 150 funding partners to ensure 19 affordable services to all; together, they have invested over 20 21 \$82 million in community grants, strategic initiatives, and policy 22 and advocacy partnerships in an effort to increase access to care 23 and to improve food security, digital inclusion, and economic 24 mobility; one impressive example is the collaboration between

- 9 Award for Performance Excellence from the Quality Texas Foundation
- 10 Regional Program, and it was one of only two organizations that

- 12 for its leadership, strategic planning, measurement, analysis and
- 13 knowledge management, results, and focus on its customers,
- 14 workforce, and operations; and

- 16 and compassionate care to countless men, women, and children in San
- 17 Antonio and beyond, and the members of its medical, support, and
- 18 administrative staff may indeed take great pride in its outstanding
