

R E S O L U T I O N

1 WHEREAS, Americans across the country will pause on March 31,  
2 2025, Cesar Chavez Day, to pay tribute to the inspiring life and  
3 achievements of the founder and longtime leader of the United Farm  
4 Workers of America on the anniversary of his birth; and

5 WHEREAS, Born in 1927 near Yuma, Arizona, and raised in  
6 California, Cesar Estrada Chavez spent much of his youth as a  
7 migrant laborer; as a Latino and a farmworker, he learned firsthand  
8 about the indignities of second-class citizenship and the unhealthy  
9 working and living conditions endured by those who tended the  
10 fields; and

11 WHEREAS, After serving in the U.S. Navy from 1946 to 1948,  
12 Cesar Chavez returned to California, and in 1948, he married Helen  
13 Fabela; four years later, he became a community organizer for the  
14 Community Service Organization, a Latino civil rights group that  
15 focused most of its work in urban areas, and by the late 1950s, he  
16 had become its national director; and

17 WHEREAS, When in 1962 the CSO declined to organize California  
18 farmworkers, Mr. Chavez and his colleague Dolores Huerta left the  
19 organization to found the National Farm Workers Association, a  
20 forerunner of the UFW; their fledgling union gained national  
21 prominence just three years later when it offered support to  
22 workers who were striking against California's grape growers; in  
23 addition to assuming leadership of the strike, Mr. Chavez launched  
24 a successful nationwide consumers' boycott of nonunion grapes; and

1           WHEREAS, By the end of the five-year-long strike, the UFW had  
2 organized all of the California table-grape industry and negotiated  
3 the first collective bargaining agreements between American  
4 farmworkers and corporations; in 1975, Mr. Chavez and the UFW  
5 succeeded in securing the passage of California's Agricultural  
6 Labor Relations Act, the first law in U.S. history granting  
7 farmworkers the right to unionize and bargain collectively;  
8 numerous other gains achieved under his leadership included the  
9 establishment of a farmworkers' medical plan, pension plan, and  
10 credit union, as well as the National Farm Workers Service Center,  
11 whose projects have included the development of affordable housing,  
12 health clinics, cooperatives, and a retirement home; and

13           WHEREAS, Over the course of his life, Cesar Chavez sought to  
14 advance La Causa, the movement, through nonviolent means--through  
15 strikes, pickets, and boycotts; on several occasions he also  
16 undertook lengthy fasts to draw public attention to the  
17 farmworkers' struggle; and

18           WHEREAS, Mr. Chavez continued to lead the UFW until his death  
19 on April 23, 1993; more than 50,000 people from throughout the  
20 nation gathered to mourn him at his funeral, indicating the  
21 far-reaching impact he had made on American society; and

22           WHEREAS, Since that time, numerous schools, streets,  
23 scholarships, monuments, buildings, and parks have been named in  
24 his memory, a number of U.S. cities have initiated annual  
25 celebrations in tribute to his life, and several states, including  
26 Texas, have declared his birthday, March 31, a state holiday; in  
27 1994, Mr. Chavez was posthumously awarded the nation's highest

1 honor, the Presidential Medal of Freedom; and

2 WHEREAS, Cesar Chavez chose to devote his life to the pursuit  
3 of social and economic justice through nonviolent means, and his  
4 courage and steadfastness in this great work brought improved  
5 health, greater security, and hope for a brighter future to  
6 countless people; now, therefore, be it

7 RESOLVED, That the House of Representatives of the 89th Texas  
8 Legislature hereby honor the life of Cesar Chavez and join the  
9 citizens of the Lone Star State in commemorating the 98th  
10 anniversary of his birth on March 31, 2025.
