2 investiture ceremony for its 11th president, Dr. Neal Weaver, on  
3 May 1, 2025; and

4 WHEREAS, Dr. Weaver was selected for this distinguished  
5 position by The University of Texas System Board of Regents in March  
6 2024, following a rigorous search process and a unanimous vote to  
7 appoint him; he began his tenure as president on May 13, 2024; and

8 WHEREAS, During the first year of his presidency, Dr. Weaver  
9 has ably guided Stephen F. Austin State University in cultivating a  
10 supportive environment for its students, faculty, and staff; he is  
11 certain to continue to lead the institution to new heights as the  
12 latest addition to The University of Texas System, with a clear

14 innovation, and strengthening its ties to the East Texas community;

3 degree from Oklahoma Panhandle State University, a master of  
4 business administration degree from Southeastern Oklahoma State  
5 University, and a doctor of philosophy degree in organizational  
6 leadership from the University of Oklahoma; and

7 WHEREAS, Dr. Neal Weaver has proven himself to be an  
8 accomplished leader in higher education and an effective advocate  
9 for students, and the Stephen F. Austin State University community  
10 is indeed fortunate to have him at the helm of the institution; now,  
11 therefore, be it
