1 WHEREAS, Residents of Victoria lost an esteemed community
2 leader and friend to many with the passing of Robby Burdge on May 5,
3 2025, at the age of 63; and

4 WHEREAS, Born in Norwalk, Ohio, on March 5, 1962, Robby
5 Burdge was the son of Adelbert and Lillian Burdge, and he grew up
6 with the companionship of seven siblings, Tena, Anette, Joni,
7 Butch, Andy, Toya, and Teri; he distinguished himself as the CEO and
8 president of klean corp international, a company he founded in 1997
9 that specializes in industrial cleaning products and technology;
10 the guiding principles of his business reflected his strong
11 religious faith as well as his belief in the importance of family,
12 teamwork, and individual responsibility; and

13 WHEREAS, A prominent member of the Victoria community,
14 Mr. Burdge was involved in numerous local civic organizations,
15 including the United Way, YMCA, Habitat for Humanity, and the Boys &
16 Girls Club of Victoria; he was an instrumental supporter of
17 Perpetual Help Home, Inc., and served on the boards of St. Joseph
18 High School, Bluebonnet Youth Ranch, the Port of Victoria, and
19 Victoria College, among others; in recognition of his
20 contributions, he was named the Victoria Rotary Citizen of the Year
21 and was twice selected as the Victoria Chamber of Commerce Citizen
22 of the Year; and

23 WHEREAS, In all his endeavors, Mr. Burdge enjoyed the love
24 and support of his wife, Tami; the couple shared a rewarding

1 marriage that spanned 42 years and welcomed the arrival of two
2 children, Casey and Conner, and later, two grandchildren, Parker
3 and Levi; Mr. Burdge relished the time he spent with his loved ones
4 at the family home in New Braunfels, where love, music, and laughter
5 were always in abundance; and

6 WHEREAS, Deeply devoted to his family, his community, and his
7 faith, Robby Burdge made a meaningful difference in many lives, and
8 he leaves behind a legacy of kindness and service that will continue
9 to inspire all who knew him; now, therefore, be it

11 Legislature hereby pay tribute to the memory of Robby Burdge and
12 extend sincere sympathy to the members of his family: to his wife,
