RESOLUTION

WHEREAS, For more than a century, the Legislative Reference

2 Library has provided invaluable assistance to Texas lawmakers; and 3 WHEREAS, Signaling to the world that the Texas Legislature early on understood the need for expert assistance from 4 5 professional library staff and the value of a specialized reference library, leaders of this state reserved a special place at the core 6 of the 1888 Capitol to house this vital resource for current and 7 future generations; the Legislative Reference Library was 8 established on the second floor in the north wing to assist members 9 of the Legislature and their staffs, and its resources are also 10 11 available to the Lieutenant Governor, the Speaker, and their 12 staffs, to the staff of the governor's office, to legislative officers, agencies, and committees, to state agencies and 13 14 commissions, to librarians and legislators from other states, to members of the press, and to Texas citizens; and 15 16 WHEREAS, The tools may change through the decades, but the need for information endures, and the library's electronic data 17 systems currently expedite the delivery of knowledge to the 18 legislative community and the people of Texas in both direct and 19 indirect ways; the creation, compilation, and utilization of 20 21 information in a reliable and timely fashion are provided today in a manner unimaginable by the Legislature in 1888, yet the importance 22 23 of the library's continued proximity to the seat of Texas government was reaffirmed during the restoration of the Capitol in 24

- 1 the 1990s, thus underscoring the intrinsic value of this treasured
- 2 institution; and
- 3 WHEREAS, The effectiveness of the library would not be
- 4 possible without the talented people who staff it; these
- 5 individuals provide in-depth analyses of legislation from all 50
- 6 states, respond to historical legislative queries, and create ad
- 7 hoc legislative statistical reports for staff in the Speaker's and
- 8 Lieutenant Governor's offices; during legislative sessions, the
- 9 library plays an integral part in the legislative process; staff
- 10 develop electronic records in the Texas Legislative Tracking System
- 11 for each bill or resolution filed and furnish real-time information
- 12 to the legislative community, to executive agencies, and to
- 13 citizens of this state through such proprietary applications as
- 14 TLIS and TLO; and
- WHEREAS, Stationed on the floor of the House and Senate
- 16 chambers, library staff record critical legislative actions as they
- 17 occur, and they work closely with the Senate and House
- 18 parliamentarians, the Senate and House journal clerks, the chief
- 19 clerk of the House, the secretary of the Senate, and their staffs to
- 20 ensure that these records are accurate and complete; library staff
- 21 members are also responsible for assigning and entering subject
- 22 terms and companion relationships to facilitate legislative
- 23 research, and they review enrolled legislation for the effective
- 24 dates of each measure; in addition, the library operates a
- 25 toll-free bill status hotline for the public; and
- 26 WHEREAS, As the statutory custodian of legislative records,
- 27 the library maintains the most comprehensive physical repository of

- 1 information relating to the Texas Legislature, including original
- 2 legislative bill files, historical and current publications of
- 3 legislative committees, state agencies, and institutions of higher
- 4 education, and legislative legal resources, journals, law reviews,
- 5 and periodicals; a circulating collection of materials is also made
- 6 available to the legislative community; and
- 7 WHEREAS, The library has undertaken an ambitious and ongoing
- 8 project to digitize historical legislative records and
- 9 information, including the House and Senate journals, to ensure
- 10 that this information is available to scholars and the public to
- 11 foster better understanding of the history of Texas and the
- 12 Legislature's role in that history; and
- WHEREAS, Each business day, the library compiles select
- 14 articles from newspapers statewide for the legislative community,
- 15 and it generates weekly listings of important journal articles and
- 16 monthly listings of newsworthy additions to the library's
- 17 collection; the library provides accurate and up-to-date
- 18 legislative information electronically through a number of
- 19 databases; the Texas Appointment System contains information on
- 20 members of state councils, boards, and committees appointed by the
- 21 governor, Lieutenant Governor, and Speaker; the Legislative
- 22 Archive System holds the only electronic version of original
- 23 legislative bill files and documentation, while the Index to
- 24 Sections Affected is the sole source of information detailing the
- 25 proposed statutory effect of bills; moreover, the library maintains
- 26 Texas Legislators: Past & Present, highlighting legislative
- 27 membership information from 1846 to today, as well as a legislative

- 1 reports database covering that same period, and it archives
- 2 gubernatorial executive orders, messages, and proclamations; and
- 3 WHEREAS, Guided skillfully by director Mary Camp, the LRL
- 4 staff includes assistant director Catherine Wusterhausen,
- 5 librarians Tricia Bailey, Ali Dzienkowski, Colton Chambers, Ia
- 6 Wood, Karen McBurney, Linna Dean, and Melanie Harshman, archivists
- 7 Kaelyn Morice, Megan North, and Marrisa Talamantes, legislative
- 8 assistants Donald Brower, Michelle Martinez, Kelvin Mote, Kali
- 9 Palmer, Julia Walden, and Jay Young, library assistants Megan
- 10 Hodson, Bailey Williams, Josh Sklar, and Fernanda Zamora, and
- 11 clipping service staff David Wood, Christopher Taylor, and Vincent
- 12 Cowan; and
- 13 WHEREAS, These hardworking and dedicated professionals
- 14 demonstrate an unyielding commitment to excellence as they carry on
- 15 the long and storied tradition of their agency, and they may take
- 16 justifiable pride in the important services they provide to the
- 17 Legislature and to the citizens of the Lone Star State; now,
- 18 therefore, be it
- 19 RESOLVED, That the House of Representatives of the 89th Texas
- 20 Legislature hereby honor the Legislative Reference Library and
- 21 extend to the staff members sincere appreciation for their
- 22 outstanding contributions; and, be it further
- 23 RESOLVED, That an official copy of this resolution be
- 24 prepared for the library as an expression of high regard by the
- 25 Texas House of Representatives.
