SECTION 1. Chapter 54, Government adding Subchapter EE to read as follows: Government Code,

SUBCHAPTER EE. BELL COUNTY CRIMINAL MAGISTRATES

APPOINTMENT. 54.1601. (a) The Commissioners Court of County may select magistrates to serve the courts of Bell County having jurisdiction in criminal matters.

- (b) The commissioners court shall establish the minimum qualifications, salary, benefits, and other compensation of each magistrate position and shall determine whether the position is full-time or part-time. The qualifications must require the magistrate to:
- (1)have served as a justice of the peace or municipal court judge; or
   (2)

be an attorney licensed in this state.
