A BILL TO BE ENTITLED

- 2 relating to the regulation of certain nursing facilities, including
- 3 licensing requirements and Medicaid participation and
- 4 reimbursement requirements.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 540.0752(b), Government Code, is amended
- 7 to read as follows:
- 8 (b) Subject to Section 540.0701 and notwithstanding any
- 9 other law, the commission shall provide Medicaid benefits through
- 10 the STAR+PLUS Medicaid managed care program to recipients who
- 11 reside in nursing facilities. In implementing this subsection, the
- 12 commission shall ensure that:
- 13 (1) a nursing facility is paid not later than the 10th
- 14 day after the date the facility submits a clean claim;
- 15 (1-a) a nursing facility complies with the patient care
- 16 expense ratio adopted under Section 32.0286, Human Resources Code;
- 17 (2) services are used appropriately, consistent with
- 18 criteria the commission establishes;
- 19 (3) the incidence of potentially preventable events
- 20 and unnecessary institutionalizations is reduced;
- 21 (4) a Medicaid managed care organization providing
- 22 services under the program:
- 23 (A) provides discharge planning, transitional
- 24 care, and other education programs to physicians and hospitals

- 1 regarding all available long-term care settings;
- 2 (B) assists in collecting applied income from
- 3 recipients; and
- 4 (C) provides payment incentives to nursing
- 5 facility providers that:
- 6 (i) reward reductions in preventable acute
- 7 care costs; and
- 8 (ii) encourage transformative efforts in
- 9 the delivery of nursing facility services, including efforts to
- 10 promote a resident-centered care culture through facility design
- 11 and services provided;
- 12 (5) a portal is established that complies with state
- 13 and federal regulations, including standard coding requirements,
- 14 through which nursing facility providers participating in the
- 15 program may submit claims to any participating Medicaid managed
- 16 care organization;
- 17 (6) rules and procedures relating to certifying and
- 18 decertifying nursing facility beds under Medicaid are not affected;
- 19 and
- 20 (7) a Medicaid managed care organization providing
- 21 services under the program, to the greatest extent possible, offers
- 22 nursing facility providers access to:
- 23 (A) acute care professionals; and
- (B) telemedicine, when feasible and in
- 25 accordance with state law, including rules adopted by the Texas
- 26 Medical Board[; and
- 27 [(8) the commission approves the staff rate

- 1 enhancement methodology for the staff rate enhancement paid to a
- 2 nursing facility that qualifies for the enhancement under the
- 3 program].
- 4 SECTION 2. Subchapter F, Chapter 540, Government Code, is
- 5 amended by adding Section 540.0283 to read as follows:
- 6 Sec. 540.0283. NURSING FACILITY PROVIDER AGREEMENTS:
- 7 COMPLIANCE WITH PATIENT CARE EXPENSE RATIO. (a) A contract to
- 8 which this subchapter applies must require that each provider
- 9 agreement between the contracting Medicaid managed care
- 10 organization and a nursing facility include a requirement that the
- 11 facility comply with the patient care expense ratio adopted under
- 12 Section 32.0286, Human Resources Code.
- 13 (b) This section does not apply to a state-owned facility.
- 14 SECTION 3. Section 242.032, Health and Safety Code, is
- 15 amended by adding Subsection (b-1) to read as follows:
- 16 (b-1) The application must:
- 17 (1) include the name of each person with a direct or
- 18 indirect ownership interest of five percent or more in:
- 19 (A) the nursing facility, including a subsidiary
- 20 or parent company of the facility; and
- 21 (B) the real property on which the nursing
- 22 <u>facility is located, including any owner, common owner, tenant, or</u>
- 23 sublessee; and
- 24 (2) describe the exact ownership interest of each of
- 25 those persons in relation to the facility or property.
- SECTION 4. Subchapter B, Chapter 242, Health and Safety
- 27 Code, is amended by adding Section 242.0333 to read as follows:

1	Sec. 242.0333. NOTIFICATION OF CHANGE TO OWNERSHIP INTEREST
2	APPLICATION INFORMATION. A license holder shall notify the
3	commission, in the form and manner the commission requires, of any
4	change to the ownership interest application information provided
5	under Section 242.032(b-1).
6	SECTION 5. Subchapter B, Chapter 32, Human Resources Code,
7	is amended by adding Section 32.0286 to read as follows:
8	Sec. 32.0286. ANNUAL PATIENT CARE EXPENSE RATIO FOR
9	REIMBURSEMENT OF CERTAIN NURSING FACILITY PROVIDERS. (a) In this
10	section, "patient care expense":
11	(1) includes an expense incurred by a nursing facility
12	<pre>for:</pre>
13	(A) providing compensation and benefits to:
14	(i) direct care staff of a facility,
15	whether the staff are employees of or contract labor for the
16	<pre>facility, including:</pre>
17	(a) licensed registered nurses and
18	licensed vocational nurses, including directors of nursing and
19	assistant directors of nursing;
20	(b) medication aides;
21	(c) restorative aides;
22	(d) nurse aides who provide
23	nursing-related care to residents occupying medical assistance
24	beds;
25	(e) licensed social workers; and
26	(f) social services assistants;
27	(ii) additional staff associated with

1	providing care to facility residents with a severe cognitive
2	<pre>impairment;</pre>
3	(iii) nonprofessional administrative
4	staff, including medical records staff and accounting or
5	<pre>bookkeeping staff;</pre>
6	(iv) central supply staff and ancillary
7	<pre>facility staff;</pre>
8	(v) laundry staff; and
9	<pre>(vi) food service staff;</pre>
10	(B) central supply costs and ancillary costs for
11	facility services and supplies, including:
12	(i) diagnostic laboratory and radiology
13	costs;
14	(ii) durable medical equipment costs,
15	including costs to purchase, rent, or lease the equipment;
16	(iii) costs for oxygen used to provide
17	<pre>oxygen treatment;</pre>
18	(iv) prescription and nonprescription drug
19	costs; and
20	(v) therapy consultant costs; and
21	(C) costs for dietary and nutrition services,
22	including costs for:
23	(i) food service and related supplies; and
24	(ii) nutritionist services; and
25	(2) does not include an expense for:
26	(A) administrative or operational costs, other
27	than administrative or operational costs described by Subdivision

- 1 (1); or
- 2 (B) fixed capital asset costs.
- 3 (b) The executive commissioner by rule shall establish an
- 4 annual patient care expense ratio, including a process for
- 5 determining the ratio, applicable to the reimbursement of nursing
- 6 facility providers for providing services to recipients under the
- 7 medical assistance program. In establishing the ratio, the
- 8 executive commissioner shall require that at least 85 percent of
- 9 the portion of the medical assistance reimbursement amount paid to
- 10 a nursing facility that is attributable to patient care expenses is
- 11 spent on reasonable and necessary patient care expenses.
- 12 (c) The executive commissioner shall adopt rules necessary
- 13 to ensure each nursing facility provider that participates in the
- 14 medical assistance program complies with the patient care expense
- 15 ratio adopted under this section.
- 16 (d) Except as provided by Subsection (e) and to the extent
- 17 permitted by federal law, the commission may recoup all or part of
- 18 the medical assistance reimbursement amount paid to a nursing
- 19 facility that is subject to the patient care expense ratio under
- 20 this section if the facility fails to spend the reimbursement
- 21 amount in accordance with the patient care expense ratio.
- (e) The commission may not recoup a medical assistance
- 23 reimbursement amount under Subsection (d) if, during the period
- 24 patient care expenses attributable to the reimbursement amount are
- 25 calculated, the facility:
- 26 (1) held at least a four-star rating under the Centers
- 27 for Medicare and Medicaid Services five-star quality rating system

1	for nursing facilities in two or more of the following categories:
2	(A) overall;
3	(B) health inspections;
4	(C) staffing; and
5	(D) long-stay quality measures;
6	(2) both:
7	(A) maintained an average daily occupancy rate of
8	75 percent or less; and
9	(B) spent at least 70 percent of the portion of
10	the reimbursement amount paid to the facility that was attributable
11	to patient care expenses on reasonable and necessary patient care
12	expenses; or
13	(3) incurred expenses related to a disaster for which
14	the governor issued a disaster declaration under Chapter 418,
15	Government Code.
16	(f) The commission shall publish and maintain on the
17	commission's Internet website a list of all nursing facilities from
18	which the commission recouped medical assistance reimbursement
19	amounts under Subsection (d).
20	(g) The commission may not require a nursing facility to
21	comply with the patient care expense ratio as a condition of
22	participation in the medical assistance program.
23	(h) This section does not apply to a state-owned facility.
24	SECTION 6. Sections $32.028(g)$, (i), and (m), Human
25	Resources Code, are repealed.
26	SECTION 7. (a) The Health and Human Services Commission
27	shall, subject to this section, require compliance with the initial

- 1 annual patient care expense ratio adopted under Section 32.0286,
- 2 Human Resources Code, as added by this Act, beginning on September
- 3 1, 2025.
- 4 (b) The Health and Human Services Commission shall, in a
- 5 contract between the commission and a managed care organization
- 6 under Chapter 540, Government Code, that is entered into or renewed
- 7 on or after the effective date of this Act, require the managed care
- 8 organization to comply with Section 540.0283, Government Code, as
- 9 added by this Act.
- 10 (c) The Health and Human Services Commission shall seek to
- 11 amend contracts entered into with managed care organizations under
- 12 Chapter 533 or 540, Government Code, before the effective date of
- 13 this Act to require those managed care organizations to comply with
- 14 Section 540.0283, Government Code, as added by this Act. To the
- 15 extent of a conflict between that section and a provision of a
- 16 contract with a managed care organization entered into before the
- 17 effective date of this Act, the contract provision prevails.
- SECTION 8. Not later than November 1, 2027, the Health and
- 19 Human Services Commission shall prepare and submit to the
- 20 legislature a written report that includes an assessment of the
- 21 impact of the patient care expense ratio established under Section
- 22 32.0286, Human Resources Code, as added by this Act, on nursing
- 23 facility care provided to Medicaid recipients during the preceding
- 24 state fiscal biennium, including the impact on the cost and quality
- 25 of care and any other information the commission determines
- 26 appropriate.
- 27 SECTION 9. If before implementing any provision of this Act

- 1 a state agency determines that a waiver or authorization from a
- 2 federal agency is necessary for implementation of that provision,
- 3 the agency affected by the provision shall request the waiver or
- 4 authorization and may delay implementing that provision until the
- 5 waiver or authorization is granted.
- 6 SECTION 10. This Act takes effect September 1, 2025.
