8	recorded unless <u>:</u>
9	(1) if the instrument is filed for recording by an
10	attorney, title agent, title company, or escrow company that
11	provides closing, settlement, or other comparable transaction
12	services in connection with the transfer of real property, a public
13	utility, a governmental entity, or a person acting on behalf of the
14	attorney, agent, company, utility, or entity, the instrument [it]
15	is signed by the grantor and:
16	(A) [and] acknowledged or sworn to by the grantor
17	in the presence of two or more credible subscribing witnesses; or
18	<u>(B)</u> acknowledged or sworn to <u>by the grantor</u>
19	before and certified by an officer authorized to take
20	acknowledgements or oaths, as applicable; and
21	(2) if the instrument is filed for recording by an
22	individual other than a person described by Subdivision (1), the
23	instrument is:
24	(A) signed by the grantor;
25	(B) acknowledged or sworn to by the grantor in
26	the presence of two or more credible subscribing witnesses; and
27	(C) acknowledged or sworn to by the grantor and

each subscribing witness before and certified by an officer 1 2 authorized to take acknowledgements or oaths, as applicable. (b-1) An affidavit of heirship concerning heirship to real 3 property that is filed for recording by a person described by 4 Subsection (b)(2) may not be recorded unless it is: 5 6 (1) signed by the individual making the affidavit; 7 (2) acknowledged or sworn to by the individual making the affidavit in the presence of two credible subscribing 8 9 witnesses; 10 (3) acknowledged or sworn to by the individual making the affidavit and each subscribing witness before and certified by 11 an officer authorized to take acknowledgements or oaths, as 12 13 applicable; and (4) acknowledged or sworn to by each living heir to 14 15 real property named in the affidavit that is not under a legal 16 disability before and certified by an officer authorized to take acknowledgements or oaths, as applicable. 17 18 SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 19 provided by Section 39, Article III, Texas Constitution. If this 20 Act does not receive the vote necessary for immediate effect, this 21 Act takes effect September 1, 2025. 22
