A BILL TO BE ENTITLED

AN ACT

2 relating to requiring the use of electronically readable 3 information to verify a purchaser's age in the retail sale of 4 alcoholic beverages. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. This Act shall be known as the Deshawn Jagwan 7 Act.

8 SECTION 2. Section 109.61, Alcoholic Beverage Code, is 9 amended by adding Subsections (a-1), (a-2), (a-3), (a-4), and (d-1) 10 and amending Subsections (b) and (d) to read as follows:

11 (a-1) A person shall visually inspect and access 12 electronically readable information on a driver's license, commercial driver's license, or identification certificate for the 13 14 purpose of verifying a purchaser's age in any retail sale of an alcoholic beverage for off-premises consumption. A person required 15 to access electronically readable information under this 16 subsection may manually enter into an electronic reader the 17 information on the driver's license, commercial driver's license, 18 or identification certificate if the license or certificate cannot 19 be electronically scanned. This subsection does not apply to: 20 21 (1) the retail sale of an alcoholic beverage on the

9	(2) the retail sale of an alcoholic beverage at a

13	holder authorized to sell alcoholic beverages during the event;
14	(3) the holder of a carrier permit delivering wine to

7	(2) the permit or license holder visually inspected
8	the purchaser's driver's license, commercial driver's license, or
9	identification certificate to verify the purchaser's age.
10	(a-3) The commission may not take any disciplinary action
11	against the holder of a permit or license to whom Subsection (a-1)
12	applies for selling an alcoholic beverage to a minor if:
13	(1) the permit or license holder electronically
14	accessed the electronically readable information on the
15	purchaser's driver's license, commercial driver's license, or

4 (d) Except as provided by Subsection (d-1), a [A] person who
5 violates this section commits an offense. An offense under this
6 section is a Class A misdemeanor.

7 (d-1) It is a defense to prosecution for failure to access 8 electronically readable information on a driver's license, 9 commercial driver's license, or identification certificate as 10 required by Subsection (a-1) that:

11 (1) the person's failure to access the electronically 12 readable information as required by Subsection (a-1) was caused by 13 a disruption of, interruption of, or inability to access Internet 14 connectivity services or data connectivity services that prevented 15 the person from accessing the information; or

16(2) the purchaser was 40 years of age or older on the17date of the purchase.

SECTION 3. Not later than September 1, 2027, the Texas Alcoholic Beverage Commission shall adopt rules to implement Section 109.61(a-1), Alcoholic Beverage Code, as added by this Act. SECTION 4. This Act takes effect September 1, 2025.
