A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the approval of a community supervision and corrections
- 3 department's budget and strategic plan.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 76.002(a), Government Code, is amended
- 6 to read as follows:
- 7 (a) The district judge or district judges trying criminal
- 8 cases in each judicial district and the statutory county court
- 9 judges trying criminal cases in the county or counties served by the
- 10 judicial district shall:
- 11 (1) establish a community supervision and corrections
- 12 department; and
- 13 (2) review [approve] the department's budget and
- 14 strategic plan following the division's approval of the budget and
- 15 plan.
- SECTION 2. Section 76.0045(b), Government Code, is amended
- 17 to read as follows:
- 18 (b) The responsibility of a judge described by Section
- 19 76.002 for budgetary decisions is limited to:
- 20 (1) appointment of a fiscal officer; and
- 21 (2) review [approval] of the department's budget
- 22 following the division's approval of the budget.
- SECTION 3. Section 509.004(a), Government Code, is amended
- 24 to read as follows:

- 1 (a) The division shall require each department to:
- 2 (1) keep financial and statistical records determined
- 3 necessary by the division;
- 4 (2) submit the department's budget and [a] strategic
- 5 plan and all supporting information requested by the division;
- 6 (3) present data requested by the division as
- 7 necessary to determine the amount of state aid for which the
- 8 department is eligible;
- 9 (4) submit periodic financial audits and statistical
- 10 reports to the division; and
- 11 (5) submit to the Department of Public Safety the full
- 12 name, address, date of birth, social security number, and driver's
- 13 license number of each person restricted to the operation of a motor
- 14 vehicle equipped with a device that uses a deep-lung breath
- 15 analysis mechanism to make impractical the operation of the motor
- 16 vehicle if ethyl alcohol is detected in the breath of the restricted
- 17 operator.
- 18 SECTION 4. The heading to Section 509.007, Government Code,
- 19 is amended to read as follows:
- 20 Sec. 509.007. DEPARTMENT BUDGET AND STRATEGIC PLAN.
- 21 SECTION 5. Section 509.007, Government Code, is amended by
- 22 amending Subsection (a) and adding Subsections (a-1) and (a-2) to
- 23 read as follows:
- 24 (a) The division shall require as a condition to payment of
- 25 state aid to a department or county under Section 509.011 that:
- 26 (1) the department submit the department's budget for
- 27 the state fiscal biennium and a strategic plan to the division; and

- 1 (2) the department's budget and plan be approved by the
- 2 <u>division</u> [be submitted for the department. The department shall
- 3 submit the plan required by this subsection. A department may not
- 4 submit a plan under this section unless the plan is first approved
- 5 by the judges described by Section 76.002 who established the
- 6 department].
- 7 (a-1) A [The] department shall submit a revised strategic
- 8 plan to the division each even-numbered year not later than March 1.
- 9 <u>(a-2)</u> A <u>department's budget or strategic</u> plan may be amended
- 10 at any time with the approval of the division.
- 11 SECTION 6. Section 140.004, Local Government Code, is
- 12 amended to read as follows:
- 13 Sec. 140.004. BUDGETS OF CERTAIN JUVENILE BOARDS [AND
- 14 COMMUNITY SUPERVISION AND CORRECTIONS DEPARTMENTS]. (a) This
- 15 section applies only to [+
- 16 $\left[\frac{1}{2}\right]$ a juvenile board, juvenile probation office, or
- 17 juvenile department established for one or more counties[; and
- 18 [(2) a community supervision and corrections
- 19 department established for a judicial district].
- 20 (b) Before the 45th day before the first day of the fiscal
- 21 year of a county, a juvenile board [and a community supervision and
- 22 $\frac{\text{corrections department}}{\text{department}}$ that $\frac{\text{has}}{\text{leach have}}$ jurisdiction in the
- 23 county shall:
- 24 (1) prepare a budget for the board's [or department's]
- 25 next fiscal year; and
- 26 (2) hold a meeting to finalize the budget.
- 27 (c) Before the 14th day before the juvenile board [or

- 1 community supervision and corrections department] has a meeting to
- 2 finalize its budget, the board [or department] shall file with the
- 3 commissioners court:
- 4 (1) a copy of the proposed budget; and
- 5 (2) a statement containing the date of the board's [or 6 department's] meeting to finalize its budget.
- 7 (d) Before the later of the 90th day after the last day of
- 8 the juvenile board's [or community supervision and corrections
- 9 department's fiscal year, or the date the county auditor's annual
- 10 report is made to the commissioners court, the board $[\frac{\partial r}{\partial x}]$
- 11 department] shall file with the commissioners court a complete
- 12 financial statement of the board [or department] covering the
- 13 board's [or department's] preceding fiscal year.
- 14 (e) The financial statement required by Subsection (d) must
- 15 contain any information considered appropriate by the juvenile
- 16 board [or community supervision and corrections department] and any
- 17 information required by the commissioners court of each county in
- 18 which the board [or department] has jurisdiction.
- 19 (f) The budget for a juvenile board [or community
- 20 supervision and corrections department] may not include an
- 21 automobile allowance for a member of the governing body of the board
- 22 [or department] if the member holds another state, county, or
- 23 municipal office. The budget may include reimbursement of actual
- 24 travel expenses, including mileage for automobile travel, incurred
- 25 while the member is engaged in the official business of the board
- 26 [or department].
- 27 SECTION 7. This Act takes effect September 1, 2025.
