2 SECTION 5. Section 1071.301(a), Occupations Code, is 3 amended to read as follows:

4 (a) The board by rule shall provide:

5 (1) that each certificate of registration or license 6 under this chapter is valid for a term of <u>not less than</u> [one year or] 7 two years; and

8 (2) for the renewal of the certificate or license.

9 SECTION 6. As soon as practicable after the effective date 10 of this Act, the Texas Board of Professional Engineers and Land 11 Surveyors shall adopt rules to implement Sections 1001.351(a) and 12 1071.301(a), Occupations Code, as amended by this Act.

13 SECTION 7. This Act takes effect September 1, 2025.
