Section 12A.004(a), Education Code, is amended 5 to read as follows: 6 7 (a) A local innovation plan may not provide for the exemption of a district designated as a district of innovation from 8 9 the following provisions of this title: (1) a state or federal requirement applicable to an 10 11 open-enrollment charter school operating under Subchapter D, 12 Chapter 12; 13 Subchapters A, C, D, and E, Chapter 11, except that (2) 14 a district may be exempt from Sections 11.1511(b)(5) and (14) and Section 11.162; 15 16 (3) transfers of students who are the children of peace officers under Section 25.0344; 17 18 <u>(4)</u> [(3)] state curriculum and graduation requirements adopted under Chapter 28; and 19 20 (5) [(4)] academic and financial accountability and 21 sanctions under Chapters 39 and 39A. 22 SECTION 2. Section 25.0344, Education Code, as added by Chapter 322 (H.B. 1959), Acts of the 88th Legislature, Regular 23 Session, 2023, is amended by amending Subsection (b) and adding 24

1 Subsections (e) and (f) to read as follows:

2 (b) On request of a peace officer who is a parent of or 3 person standing in parental relation to a student, the board of 4 trustees of a school district or the board's designee shall 5 transfer the student to:

(1) another district campus; or

7 (2) any other [to another] school district in this 8 state, regardless of whether the sending district and the receiving 9 district have entered into [under] an agreement under Section 10 25.035.

11 (e) Notwithstanding any other law, both the sending 12 district and the receiving district must approve a transfer under 13 this section without exception.

14 (f) A school district may not charge a tuition fee under 15 Section 25.038 to a student who transfers to the district under this 16 section.

SECTION 3. Section 12A.004(a), Education Code, as amended by this Act, applies only to a local innovation plan adopted or renewed on or after the effective date of this Act. A local innovation plan adopted or renewed before the effective date of this Act is governed by the law in effect on the date the plan was adopted or renewed, and the former law is continued in effect for that purpose.

24 SECTION 4. This Act applies beginning with the 2025-2026 25 school year.

26 SECTION 5. This Act takes effect immediately if it receives 27 a vote of two-thirds of all the members elected to each house, as

provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2025.
