## A BILL TO BE ENTITLED

## AN ACT

2 relating to the use of the skills development fund by certain 3 entities.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 303.001(a), Labor Code, is amended to 6 read as follows:

7 (a) The purpose of this chapter is to remove administrative barriers that impede the response of public community and technical 8 9 colleges, community-based organizations, local workforce development boards, the Texas A&M Engineering Experiment Station, 10 11 and the Texas A&M Engineering Extension Service to industry and 12 workforce training needs and to develop incentives for public community and technical colleges, community-based organizations, 13 14 local workforce development boards, the Texas A&M Engineering Experiment Station, and the Texas A&M Engineering Extension Service 15 16 to provide customized assessment and training in a timely and efficient manner. 17

18 SECTION 2. Section 303.002(b), Labor Code, is amended to 19 read as follows:

(b) A public community or technical college, the Texas A&M
21 <u>Engineering Experiment Station</u>, or the Texas A&M Engineering
22 Extension Service may recover customized assessment and training
23 costs incurred by the <u>college</u>, <u>station</u>, <u>or service</u> [<u>institution</u>]
24 if:

1 (1) there is an actual or projected labor shortage in 2 the occupation in which training is provided that is not being met 3 by an existing institution or program in the area; and

4 (2) the wages at the time of job placement for
5 individuals who successfully complete customized training at the
6 public community or technical college, the Texas A&M Engineering
7 Experiment Station, or the Texas A&M Engineering Extension Service
8 are equal to the prevailing wage for that occupation in the local
9 labor market area.

10 SECTION 3. Sections 303.003(b), (f), (g), and (h), Labor 11 Code, are amended to read as follows:

(b) The skills development fund may be used by public community and technical colleges, community-based organizations, local workforce development boards, <u>the Texas A&M Engineering</u> <u>Experiment Station</u>, and the Texas A&M Engineering Extension Service as start-up or emergency funds for the following job-training purposes:

18 (1) developing customized training programs for19 businesses and trade unions; and

20 (2) sponsoring small and medium-sized business21 networks and consortiums.

(f) The <u>Texas A&M Engineering Experiment Station and the</u> Texas A&M Engineering Extension Service shall focus the <u>station's</u> <u>or</u> service's training activities under this chapter on programs that:

26 (1) are statewide in nature; or27 (2) are not available from a local junior college

district, a local technical college, or a consortium of junior
 college districts.

3 (g) This section does not prohibit <u>the Texas A&M Engineering</u>
4 <u>Experiment Station or</u> the Texas A&M Engineering Extension Service
5 from participating in a consortium of junior college districts or
6 with a technical college that provides training under this chapter.

(h) A community-based organization may apply for money to
participate in a training program only in partnership with a
community and technical college, the Texas A&M Engineering
<u>Experiment Station</u>, or the Texas A&M Engineering Extension Service.
A community-based organization providing services regulated by the
state shall provide evidence of any certification, license, or
registration required by law.

14 SECTION 4. Section 303.004, Labor Code, is amended to read 15 as follows:

16 Sec. 303.004. FUND REVIEW; REPORT BY CERTAIN WORKFORCE 17 TRAINING PROVIDERS REQUIRED. (a) The Texas Higher Education 18 Coordinating Board shall review all customized training programs 19 biennially to verify that state funds are being used appropriately 20 by public community and technical colleges, the Texas A&M 21 <u>Engineering Experiment Station</u>, and the Texas A&M Engineering 22 Extension Service under this chapter.

(b) Not later than October 1 of each even-numbered year, <u>the</u>
<u>Texas A&M Engineering Experiment Station</u>, the Texas A&M Engineering
Extension Service, and each public community or technical college
that provides workforce training under this chapter shall:

27 (1) conduct a review of the <u>station's</u>, service's, or

1 college's training programs to:

2 (A) determine the effectiveness of the programs
3 in improving the wages of participants who complete the programs;
4 and

5 (B) identify strategies for improving the 6 delivery of workforce training in order to more effectively impact 7 economic development in this state; and

8 (2) submit to the commission a detailed written report 9 summarizing the results of the review for inclusion by the 10 executive director in the report to the governor and the 11 legislature required by Section 303.006(c).

12 (c) If <u>the Texas A&M Engineering Experiment Station</u>, the 13 Texas A&M Engineering Extension Service, or a public community or 14 technical college fails to submit a report required by Subsection 15 (b)(2):

16 (1) the <u>station</u>, service, or college must refund to
17 the comptroller any unexpended state funds received by the <u>station</u>,
18 service, or college under this chapter for the state fiscal
19 biennium in which the report was due; and

20 (2) the commission may not award any additional grant 21 to the <u>station</u>, service, or college under this chapter until the 22 <u>station</u>, service, or college has complied with that reporting 23 requirement.

SECTION 5. This Act takes effect September 1, 2025.
