4	SECTION 1. The heading to Section 545.305, Transportation
5	Code, is amended to read as follows:
6	Sec. 545.305. <u>AUTHORIZED</u> REMOVAL OF <u>CERTAIN MOTOR VEHICLES</u>
7	[UNLAWFULLY STOPPED VEHICLE].
8	SECTION 2. Section 545.305(a), Transportation Code, is
9	amended to read as follows:
10	(a) A peace officer listed under Article 2A.001, Code of
11	Criminal Procedure, or a license and weight inspector of the
12	department may remove or require the operator or a person in charge
13	of a vehicle to move a vehicle from a highway if the vehicle:
14	(1) is unattended on a bridge, viaduct, or causeway or
15	in a tube or tunnel and the vehicle is obstructing traffic;
16	(2) is unlawfully parked and blocking the entrance to
17	a private driveway;
18	(3) has been reported as stolen;
19	(4) is identified as having been stolen in a warrant
20	issued on the filing of a complaint;
21	(5) is unattended and the officer has reasonable
22	grounds to believe that the vehicle has been abandoned for longer
23	than 48 hours;
24	(6) is disabled so that normal operation is impossible

or impractical and the owner or person in charge of the vehicle is: 1 2 (A) incapacitated and unable to provide for the vehicle's removal or custody; or 3 not in the immediate vicinity of the vehicle; 4 (B) 5 (7) is disabled so that normal operation is impossible or impractical and the owner or person in charge of the vehicle does 6 7 not designate a particular towing or storage company; (8) is operated by a person: 8 9 (A) an officer arrests for an alleged offense and the officer is required by law to take the person into custody; or 10 (B) in violation of Section 521.021, 521.457, 11 601.191, or 729.002; or 12 is, in the opinion of the officer, a hazard, 13 (9) interferes with a normal function of a governmental agency, or 14 15 because of a catastrophe, emergency, or unusual circumstance is 16 imperiled. 17 SECTION 3. This Act takes effect September 1, 2025.
