1-22 AN ACT

1-23 relating to the eligibility of postsecondary educational
1-24 institutions to participate in the governor's university research
1-25 initiative.

1-26 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-27 SECTION 1. Section 62.003(1), Education Code, is amended to
1-28 read as follows:

1-29 (1) Except as otherwise provided by Subchapters C, D,
1-30 E, F, G, H, and I, "eligible institution" means the eligible
1-31 agencies and institutions of higher education listed in ~~[Article~~
1-32 ~~VII,]~~ Section 17(b), Article VII, Texas [of the] Constitution [of
1-33 ~~Texas]~~, and any institution or agency of higher education that is
1-34 later made eligible to participate in the disbursement of funds
1-35 pursuant to ~~[Article VII,]~~ Section 17(c) of that article~~[, of the~~
1-36 ~~Constitution of Texas].~~

1-37 SECTION 2. Section 62.161(2), Education Code, is amended to
1-38 read as follows:

1-39 (2) "Eligible institution" means:
1-40 (A) a general academic teaching institution;
1-41 (B) a ~~[or]~~ medical and dental unit; or
1-42 (C) a private or independent institution of
1-43 higher education.

1-44 SECTION 3. Section 62.163(d), Education Code, is amended to
1-45 read as follows:

1-46 (d) A matching grant may not be used by an eligible
1-47 institution to recruit a distinguished researcher from~~+~~
1-48 ~~[(1)] another eligible institution~~~~[, or~~
1-49 ~~[(2)] a private or independent institution of higher~~
1-50 ~~education].~~

1-51 SECTION 4. Sections 62.161(2) and 62.163(d), Education
1-52 Code, as amended by this Act, apply beginning with grants awarded
1-53 for the 2025-2026 academic year.

1-54 SECTION 5. This Act takes effect immediately if it receives
1-55 a vote of two-thirds of all the members elected to each house, as
1-56 provided by Section 39, Article III, Texas Constitution. If this
1-57 Act does not receive the vote necessary for immediate effect, this
1-58 Act takes effect September 1, 2025.
