- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 614.171(1), Government Code, is amended 7 to read as follows:
- 8 (1) "Law enforcement agency" means the Department of
- 9 Public Safety, Texas Alcoholic Beverage Commission, Texas
- 10 Department of Criminal Justice, Parks and Wildlife Department, [and
- 11 the] office of the attorney general, and Texas Juvenile Justice
- 12 Department.
- SECTION 2. Section 659.303, Government Code, is amended by
- 14 amending Subsections (a) and (d) and adding Subsection (a-1) to
- 15 read as follows:
- 16 (a) The department may include hazardous duty pay in the
- 17 compensation paid to an individual for services rendered during a
- 18 month if the individual[+
- 20 (1) $[\frac{A}{A}]$ routine direct contact with youth:
- 21 $\underline{\text{(A)}}$ [$\frac{\text{(i)}}{\text{)}}$] placed in a residential facility of the
- 22 department; or
- 23 (B) [(ii)] released under the department's
- 24 supervision; and

- 1 $\underline{(2)}$ [(B)] completed at least 12 months of lifetime
- 2 service credit not later than the last day of the preceding month.
- 3 (a-1) The department shall include hazardous duty pay in the
- 4 compensation paid to an individual for services rendered during a
- 5 month if the individual[+ or
- $[\frac{(2)}{2}]$ is an investigator, inspector general, security
- 7 officer, or apprehension specialist employed by the office of the
- 8 inspector general of the department.
- 9 (d) Except for the inclusion of hazardous duty pay in the
- 10 compensation paid to an individual described by Subsection (a-1)
- 11 $[\frac{(a)(2)}{2}]$, the department may not pay hazardous duty pay:
- 12 (1) from funds authorized for payment of an
- 13 across-the-board employee salary increase; or
- 14 (2) to an employee who works at the department's
- 15 central office.
- SECTION 3. Section 661.918(a), Government Code, is amended
- 17 to read as follows:
- 18 (a) This section applies to a peace officer under Article
- 19 2A.001, Code of Criminal Procedure, who is commissioned as a law
- 20 enforcement officer or agent, including a ranger, by:
- 21 (1) the Public Safety Commission and the director of
- 22 the Department of Public Safety;
- 23 (2) the Parks and Wildlife Commission;
- 24 (3) the Texas Alcoholic Beverage Commission;
- 25 (4) the attorney general; [or]
- 26 (5) the insurance fraud unit of the Texas Department
- 27 of Insurance; [or]

- 1 (6) the comptroller; or
- 2 (7) the office of the inspector general of the Texas
- 3 Juvenile Justice Department.
- 4 SECTION 4. Section 242.102, Human Resources Code, is
- 5 amended by adding Subsection (j) to read as follows:
- 6 (j) The department shall ensure that a peace officer
- 7 commissioned under Subsection (d) is compensated according to
- 8 Schedule C of the position classification salary schedule
- 9 prescribed by the General Appropriations Act.
- 10 SECTION 5. (a) The classification officer in the office of
- 11 the state auditor shall classify the position of commissioned peace
- 12 officer employed by the office of inspector general of the Texas
- 13 Juvenile Justice Department as a Schedule C position under the
- 14 position classification plan maintained under Chapter 654,
- 15 Government Code.
- 16 (b) The change made by the classification officer as
- 17 required by this section applies beginning with the state fiscal
- 18 biennium beginning September 1, 2025.
- 19 (c) This section expires September 1, 2027.
- SECTION 6. Section 661.918(a), Government Code, as amended
- 21 by this Act, applies only to an injury that occurs on or after the
- 22 effective date of this Act.
- 23 SECTION 7. This Act takes effect September 1, 2025.
