The petition must be: 11 12 [(1) signed by at least 10 registered taxpaying 13 voters; and 14 [(2) filed by the deadline imposed by Section 144.005 15 Election Code]. SECTION 2. Section 1016.054, Special District Local Laws 16 Code, is amended to read as follows: 17 Sec. 1016.054. QUALIFICATIONS FOR OFFICE. (a) A person may 18 not be elected or appointed as a director unless the person is: 19 (1) a district resident; and 20 21 (2) a gualified voter[+ 22 [(3) a freeholder; and 23 [(4) at least 18 years of age when 24 appointed].

1 (b) A person may not be elected or appointed as a director if 2 the person is a district employee. SECTION 3. Section 1016.057, Special District Local Laws 3 4 Code, is amended to read as follows: Sec. 1016.057. OFFICERS. The board shall 5 elect a president, a vice president, and a secretary from among its 6 7 members. SECTION 4. The heading to Section 1016.060, 8 Special 9 District Local Laws Code, is amended to read as follows: Sec. 1016.060. DISTRICT ADMINISTRATOR [- ASSISTANT 10 11 ADMINISTRATOR]. SECTION 5. Section 1016.060(c), Special District Local Laws 12 13 Code, is amended to read as follows: (c) The district administrator serves [and any assistant 14 15 administrator serve] at the will of the board and is [are] entitled 16 to the compensation determined by the board. SECTION 6. Section 1016.110, Special District Local Laws 17 Code, is amended to read as follows: 18 Sec. 1016.110. CONSTRUCTION [OR PURCHASE] CONTRACTS. 19 (a) 20 The board may enter into construction contracts for the district. (b) The board may enter into a public work contract as 21 authorized under Chapter 2269, Government Code. 22 (c) Chapter 2253, Government Code, as it relates to 23 performance and payment bonds, applies to the district's 24 construction contracts [A construction or purchase contract that 25 involves the expenditure of more than \$2,000 may be made only after 26 27 advertising in the manner provided by Chapter 252 and Subchapter C,

1 Chapter 262, Local Covernment Code]. 2 SECTION 7. Section 1016.160(a), Special District Local Laws Code, is amended to read as follows: 3 4 (a) Except as otherwise provided by Section 1016.107(c) of this code, Section 315.002, Health and Safety Code, 5 this subchapter, and Subchapter E of this chapter, the district may not 6 incur <u>a debt</u> [an obligation] payable from district revenue other 7 than the revenue on hand or to be on hand in the current and 8 9 following district fiscal years. 10 SECTION 8. The following provisions of the Special District Local Laws Code are repealed: 11 (1) Section 1016.055; and 12 Sections 1016.060(b) and (d). 13 (2) SECTION 9. (a) The changes in law made by this Act to 14 Section 1016.053, Special District Local Laws Code, apply only to 15 16 an election ordered on or after the effective date of this Act. 17 (b) The changes in law made by this Act to Section 1016.054, Special District Local Laws Code: 18 (1) do not affect the entitlement of a director 19 serving on the board of directors immediately before the effective 20 date of this Act to continue to serve on the board for the remainder 21 of the director's term; 22 apply only to a member of the board of directors 23 (2) 24 elected or appointed to the board on or after the effective date of 25 this Act; and do not prohibit a director serving on the board of 26 (3) 27 directors on the effective date of this Act from being reelected or

required for membership on the board under Section 1016.054,

4 SECTION 10. This Act takes effect immediately if it 5 receives a vote of two-thirds of all the members elected to each 6 house, as provided by Section 39, Article III, Texas Constitution. 7 If this Act does not receive the vote necessary for immediate 8 effect, this Act takes effect September 1, 2025.
