- 18 INTEREST WITHOUT CERTIFICATE OF TITLE. (a) Except as provided by

- 21 a new certificate of title that includes an indication of a

- 16 (a) In this section, "buyer in ordinary course of business" has the
- 17 meaning assigned by Section 1.201, Business & Commerce Code.
- 18 (b) A buyer in ordinary course of business has the
- 19 protections afforded by Sections 2.403(b) and 9.320(a), Business &
- 20 Commerce Code, regardless of whether:
