21	have a mode of propulsion of its own;
22	(ii) is dependent for utilities upon a

24	(iii) has a permanent, continuous hookup to

1 <u>a shoreside sewage system</u>.

2 (8) "Vessel livery" means a <u>person</u> [business 3 establishment] engaged in <u>advertising</u>, renting, or hiring out 4 vessels for <u>consideration</u> [profit]. <u>The term includes a</u> 5 recreational equipment timeshare business that leases or rents 6 <u>vessels for consideration</u>.

7 (11) "Manufacturer" means a person engaged in the 8 business of manufacturing <u>or importing</u> new and unused vessels and 9 outboard motors for the purpose of sale or trade.

10 (19) "Cancel" means, with respect to a certificate of 11 title, to make the certificate ineffective.

12 (20) "Certificate of title" means, with respect to a 13 vessel or outboard motor, a record, created by the department under 14 this chapter or by a governmental agency of another jurisdiction 15 under the law of that jurisdiction, that is designated as a 16 certificate of title by the department or agency and is evidence of 17 ownership of a vessel or outboard motor.

18 (21) "Electronic" means relating to technology having 19 electrical, digital, magnetic, wireless, optical, electromagnetic, 20 or similar capabilities.

21 <u>(22) "Hull identification number" means the</u> 22 <u>alphanumeric designation assigned to a vessel under 33 C.F.R. Part</u> 23 <u>181.</u>

24 <u>(23) "Owner of record" or "recorded owner" means an</u> 25 <u>owner indicated in the files of the department.</u>

26 (24) "Purchase" means, with respect to a vessel or 27 outboard motor, to take by any voluntary transaction that creates

1 an interest in the vessel or outboard motor. 2 (25) "Purchaser" means a person who takes by purchase. (26) "Record" means information inscribed on a 3 tangible medium or stored in an electronic or other medium and 4 5 retrievable in perceivable form. 6 (27) "Security interest" means, with respect to a 7 vessel or outboard motor, an interest in the vessel or outboard 8 motor that secures payment or performance of an obligation if the interest is created by contract or arises under Section 2.401, 9 2.505, 2.711(c), or 2A.508(e), Business & Commerce Code, except 10 that the retention or reservation of title by a seller of a vessel 11 12 or outboard motor notwithstanding shipment or delivery to the buyer under Section 2.401 of that code is limited in effect to a 13 reservation of a security interest. The term: 14 15 (A) includes any interest of a consignor in a 16 vessel or outboard motor in a transaction that is subject to Chapter 17 9, Business & Commerce Code; and (B) does not include: 18 19 (i) the special property interest of a buyer of a vessel or outboard motor on identification of that vessel 20 or outboard motor to a contract for sale under Section 2.501, 21 22 Business & Commerce Code, unless a buyer acquires a security interest by complying with Chapter 9 of that code; 23 24 (ii) the right of a seller or lessor of a vessel or outboard motor under Chapter 2 or 2A, Business & Commerce 25 26 Code, to retain or acquire possession of the vessel or outboard 27 motor:

9	SECTION 2. Section 31.022(a), Parks and Wildlife Code, is
10	amended to read as follows:
11	(a) A vessel is not required to be numbered under the

14	exceeding 90 consecutive days and is covered by a number in full
15	force and effect which has been awarded under federal law or a
16	federally approved numbering system of another state;
17	(2) from a country other than the United States
18	temporarily using the water of this state;
19	(3) owned by the United States, a state, or a
20	subdivision of a state; [or]
21	(4) a ship's lifeboat <u>; or</u>
22	(5) an amphibious vehicle for which a certificate of
23	title is issued under Chapter 501, Transportation Code, or a
24	similar law of another state.
25	SECTION 3. Section 31.028, Parks and Wildlife Code, is
26	amended to read as follows:
27	Sec. 31.028. CERTIFICATE OF NUMBER. The certificate of

number shall be pocket-size. The certificate, [or] a facsimile of the certificate, or an electronic version of the certificate provided by the department [it] shall be carried on board the vessel at all times. It does not have to be on the person of the operator if prior to trial the operator can produce for examination a valid certificate of number.

7 SECTION 4. Section 31.037(c), Parks and Wildlife Code, is 8 amended to read as follows:

If 8 <u>requested</u>, the department shall provide a record in a format that is 9 <u>self-authenticating under Rule 902</u>, <u>Texas Rules of Evidence</u>.

SECTION 6. Sections 31.041(h) and (i), Parks and Wildlife

(i) A person purchasing a vessel may use the temporary facsimile number issued under Subsection (f) for a period not to exceed <u>20</u> [45] days from the date the dealer, distributor, or manufacturer applies for a certificate of number or a certificate of title under Subsection (h). The person shall retain the facsimile number on the vessel for the period described by this subsection.

In this subchapter: 7 (1) "Barge" means a vessel that is not self-propelled 8 or fitted for propulsion by sail, paddle, oar, or similar device. 9 (2) "Builder's certificate" means a certificate of the 10 facts of build of a vessel described in 46 C.F.R. No. 1267 (14) "Secured party of record" means the secured party 1 2 whose name is indicated as the name of the secured party in the files of the department or, if the files indicate more than one 3 secured party, the one first indicated. 4 5 (15) "Title brand" means a designation of previous damage, use, or condition that must be indicated on a certificate of 6 7 title. (16) "Transfer of ownership" means a voluntary or 8 involuntary conveyance of an interest in a vessel or an outboard 9 10 motor. (17) "Written certificate of title" means a 11 12 certificate of title consisting of information inscribed on a 13 tangible medium. 14 SECTION 9. Sections 31.045(b) and (d), Parks and Wildlife 15 Code, are amended to read as follows: (b) The ownership of a new vessel or a new outboard motor is 16 17 evidenced by a manufacturer's or [an] importer's certificate of origin executed on a form prescribed by the department. 18 19 (d) The ownership of a vessel [exempted from numbering under Section 31.022(c) of this code] is not required to be evidenced by a 20 certificate of title issued by the department for: 21 (1) a vessel exempted from numbering under Section 22 31.022(c); 23 24 (2) a watercraft owned by the United States, a state, a foreign government, or a political subdivision of the United 25 26 States, a state, or a foreign government; 27 (3) a watercraft used solely as a lifeboat on another

The applicant shall pay a fee of \$25, or an amount set by the 20 commission, whichever is greater, to the department for this 21 22 inspection.

2 (b) Subject to Subsection (c), the effect of perfection and 3 nonperfection of a security interest and the priority of a 4 perfected or unperfected security interest with respect to the 5 rights of a purchaser or creditor, including a lien creditor, is 6 governed by the Business & Commerce Code.

7 (c) If, while a security interest in a vessel or outboard 8 motor is perfected by any method under this chapter, the department 9 issues a certificate of title that does not indicate that the vessel 10 or outboard motor is subject to the security interest or contain a 11 statement that it may be subject to security interests not 12 indicated on the certificate of title:

13 (1) a buyer of the vessel or outboard motor, other than 14 a person in the business of selling or leasing vessels or outboard 15 motors of that kind, takes free of the security interest if the 16 buyer, acting in good faith and without knowledge of the security 17 interest, gives value and receives possession of the vessel or 18 outboard motor; and

19 (2) the security interest is subordinate to a 20 conflicting security interest in the vessel or outboard motor that 21 is perfected under Section 31.0569, after creation of the 22 certificate and without the conflicting secured party's knowledge 23 of the security interest.

24 SECTION 22. The following provisions of the Parks and 25 Wildlife Code are repealed:

26 (1) Section 31.039(c); and

27 (2) Sections 31.049(b) and (c).

SECTION 23. (a) The rights, duties, and interests flowing from a transaction, certificate of title, or record relating to a vessel or outboard motor which was validly entered into or issued before the effective date of this Act and would be subject to Chapter 31, Parks and Wildlife Code, as amended by this Act, if it had been entered into or issued on or after the effective date of this Act, remain valid on and after the effective date of this Act.

8 (b) This Act does not affect an action or proceeding 9 commenced before the effective date of this Act.

10 (c) Except as provided by Subsection (d) of this section, a 11 security interest that is enforceable immediately before the 12 effective date of this Act and would have priority over the rights 13 of a person that becomes a lien creditor at that time is a perfected 14 security interest under this Act.

15 (d) A security interest perfected immediately before the16 effective date of this Act remains perfected until the earlier of:

17 (1) the time perfection would have ceased under the18 law under which the security interest was perfected; or

19 (2) three years after the effective date of this Act.
20 (e) This Act does not affect the priority of a security
21 interest in a vessel or outboard motor if immediately before the
22 effective date of this Act the security interest is enforceable and
23 perfected, and that priority is established.
