5	SECTION 1. Subtitle B, Title 9, Health and Safety Code, is
6	amended by adding Chapter 786 to read as follows:
7	CHAPTER 786. SENIOR RETIREMENT COMMUNITIES
8	Sec. 786.001. DEFINITIONS. In this chapter:
9	(1) "Common amenity" means an amenity or service
10	offered or provided to residents of a multiunit residential
11	property, including:
12	(A) concierge services;
13	(B) a library;
14	(C) common dining services;
15	(D) housekeeping services; and
16	(E) full-time security.
17	(2) "Resident" means an individual who resides in a
18	senior retirement community as a unit owner or tenant.
19	(3) "Senior retirement community" means a residential
20	community or a portion of a residential community:
21	(A) described by Section 301.043, Property Code;
22	(B) that contains not fewer than 20 residential
23	units in one or more multiunit buildings that are available to rent
24	or lease; and

1	(C) that provides common amenities.
2	(4) "Senior retirement community contract" means a
3	contract with a resident of a senior retirement community for
4	providing a common amenity to the resident.
5	(5) "Unit" means a physical portion of a residential
6	property designated for separate ownership or occupancy.
7	Sec. 786.002. EXEMPTIONS. This chapter does not apply to:
8	(1) a health care institution as defined by Section
9	74.001, Civil Practice and Remedies Code;
10	(2) a boarding home facility as defined by Section
11	260.001 that holds a permit issued under Chapter 260;
12	(3) a supportive housing facility for elderly
13	individuals operated under Section 202, the National Housing Act
14	(12 U.S.C. Section 1701q);
15	(4) a center for independent living as defined by
16	Section 702 of the federal Rehabilitation Act of 1973 (29 U.S.C.
17	Section 796a); or
18	(5) any other facility that is regulated by the Health
19	and Human Services Commission or in accordance with rules adopted

21	Sec. 786.003. REQUIREMENTS RELATING TO RESIDENT SAFETY FROM
22	CRIMINAL ACTIVITY. (a) A senior retirement community shall:
23	(1) conduct for each retirement community employee a
24	criminal history record check using the computerized criminal
25	history system maintained by the Department of Public Safety of the
26	State of Texas;
27	(2) disclose in the senior retirement community

1 contract whether the retirement community requires each business that will provide services at the retirement community to conduct a 2 criminal history record check of each of the business's employees 3 who will provide services at the retirement community; and 4 5 (3) maintain a resident safety and communications policy regarding criminal activity that poses a risk to residents, 6 7 which must require the retirement community to send to each resident and post in a conspicuous manner at a location on the 8 retirement community premises where the retirement community posts 9 10 other community notices a written notice containing information on: (A) known reports of potential criminal activity 11 12 made to law enforcement from or at the retirement community not later than two business days after the date the report is made or 13 activity occurs; and 14 15 (B) known instances of trespassing at the retirement community not later than two business days after the 16 17 trespassing is reported or occurs. (b) For purposes of providing notice under the policy 18 19 adopted by a senior retirement community under Subsection (a)(3) relating to a reportable incident described by that subdivision, 20 the retirement community: 21 (1) may provide for the removal of the personal 22 identifying information of an individual who is involved in the 23 24 reportable incident to prevent the individual's identification; 25 and 26 (2) may not refuse to provide the notice based solely on concerns related to the disclosure of the individual's personal 27

2	(c) A senior retirement community may not be held civilly or
3	criminally liable for the retirement community's compliance with
4	Subsection (a)(1) or (3).
5	(d) A senior retirement community may not:
6	(1) prevent or inhibit a resident from or penalize a
7	resident for communicating with a law enforcement officer, social
8	worker, family member, or other interested person regarding the
9	safety and security of the retirement community; or
10	(2) prevent a law enforcement officer or court officer
11	from entering a common area of the retirement community to conduct a
12	voluntary interview with a resident as part of an investigation
13	into criminal activity at the retirement community.
14	SECTION 2. This Act takes effect September 1, 2025.
