4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 481, Government Code, is amended by
6	adding Subchapter HH to read as follows:
7	SUBCHAPTER HH. TEXAS ALCOHOL TOURISM DEVELOPMENT PROGRAM
8	Sec. 481.701. DEFINITION. In this subchapter, "program"
9	means the Texas alcohol tourism development program established
10	under this subchapter.
11	Sec. 481.702. TEXAS ALCOHOL TOURISM DEVELOPMENT PROGRAM.
12	(a) The office shall establish the Texas alcohol tourism
13	development program to develop and market alcohol tourism in this
14	state.
15	(b) The program shall:
16	(1) using market research develop an alcoholic
17	beverage industry marketing plan to:
18	(A) increase tourism to wineries, breweries, and
19	distilleries in this state; and
20	(B) promote the consumption of and access to
21	wine, beer, and distilled spirits produced in this state;
22	(2) develop and maintain a list of the locations of
23	wineries, breweries, and distilleries in this state;

(3) post on a publicly accessible Internet website and

- 1 annually update a list of the locations of wineries, breweries, and
- 2 distilleries in this state that offer tours and tastings;
- 3 (4) promote wineries, breweries, and distilleries in
- 4 this state when promoting this state as a tourism destination;
- 5 (5) educate consumers about the wine, beer, and
- 6 distilled spirits produced in this state; and
- 7 (6) promote, market, and educate consumers about the
- 8 alcoholic beverage industry in this state using any other method
- 9 the office determines is appropriate.
- Sec. 481.703. TEXAS ALCOHOL TOURISM DEVELOPMENT ADVISORY
- 11 COMMITTEE. (a) In this section, "advisory committee" means the
- 12 Texas alcohol tourism development advisory committee established
- 13 under this section.
- 14 (b) The Texas alcohol tourism development advisory
- 15 committee is established to advise the office on the development of
- 16 alcohol tourism in this state.
- 17 (c) The advisory committee is composed of the following nine
- 18 members appointed by the governor:
- 19 (1) a holder of a distiller's and rectifier's permit
- 20 issued under Chapter 14, Alcoholic Beverage Code;
- 21 (2) a holder of a winery permit issued under Chapter
- 22 16, Alcoholic Beverage Code;
- 23 (3) a holder of a brewer's license issued under Chapter
- 24 62, Alcoholic Beverage Code;
- 25 (4) a member of a chamber of commerce in this state;
- 26 (5) a researcher or educator specializing in economic
- 27 development;

- 1 (6) a member of the public who is not affiliated with the alcoholic beverage industry; 2 3 (7) a representative of the office; 4 (8) a representative of the Texas Department of 5 Transportation; and 6 (9) a commissioner of the Texas Alcoholic Beverage 7 Commission. 8 (d) The advisory committee shall: 9 (1) propose methods to market and increase the alcohol tourism industry in this state, as provided by Section 481.702; 10 (2) develop a plan and schedule to implement the 11 12 marketing and growth methods proposed under Subdivision (1); and (3) propose a budget and spending plan for the office 13 14 to implement the plan and the program. 15 (e) Not later than September 1, 2026, the advisory committee shall submit a report to the office and legislature detailing the 16 17 committee's proposed methods, plans, and budget, as required by this section. 18 (f) The advisory committee is abolished and this section 19 expires January 1, 2027. 20 21 SECTION 2. As soon as practicable after the effective date 22 of this Act: 23 (1)the Texas Economic Development and Tourism Office
 - (2) the governor shall appoint the members of the
