4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. This Act shall be known as the "Anti-Red Flag
6	Act."
7	SECTION 2. Title 1, Code of Criminal Procedure, is amended
8	by adding Chapter 7C to read as follows:
9	CHAPTER 7C. PROHIBITION ON RECOGNITION, SERVICE, AND ENFORCEMENT
10	OF EXTREME RISK PROTECTIVE ORDERS
11	Art. 7C.001. DEFINITIONS. In this chapter:
12	(1) "Extreme risk protective order" means a written
13	order, warrant, or executive order issued by a court or signed by a
14	<pre>magistrate or other court officer that:</pre>
15	(A) has the primary purpose of reducing the risk
16	of death or injury related to a firearm by:
17	(i) prohibiting a person from owning,
18	possessing, or receiving a firearm; or
19	(ii) requiring a person to surrender a
20	firearm or otherwise removing a firearm from a person; and
21	(B) is not issued on the basis of conduct that
22	resulted in a criminal charge for the person who is the subject of
23	the order.
24	(2) "Firearm" has the meaning assigned by Section

- 1 46.01, Penal Code.
- 2 Art. 7C.002. LOCAL REGULATION PROHIBITED. (a) This
- 3 article applies to:
- 4 (1) the State of Texas, including an agency,
- 5 department, commission, bureau, board, office, council, court, or
- 6 other entity that is in any branch of state government and that is
- 7 created by the constitution or a statute of this state, including a
- 8 university system or a system of higher education;
- 9 (2) the governing body of a municipality, county, or
- 10 special district or authority;
- 11 (3) an officer, employee, or other body that is part of
- 12 a municipality, county, or special district or authority, including
- 13 a sheriff, municipal police department, municipal attorney, or
- 14 county attorney; and
- 15 (4) a district attorney or criminal district attorney.
- (b) An entity described by Subsection (a) may not adopt or
- 17 <u>enforce a rule, ordinance, order, policy, or other similar measure</u>
- 18 relating to an extreme risk protective order unless state law
- 19 specifically authorizes the adoption and enforcement of such a
- 20 rule, ordinance, order, policy, or measure.
- 21 Art. 7C.003. CERTAIN FEDERAL LAWS UNENFORCEABLE. A federal
- 22 statute, order, rule, or regulation purporting to implement or
- 23 enforce an extreme risk protective order against a person in this
- 24 state that infringes on the person's right of due process, keeping
- 25 and bearing arms, or free speech protected by the United States
- 26 Constitution or the Texas Constitution is unenforceable as against
- 27 the public policy of this state and shall have no effect.

- 1 Art. 7C.004. ACCEPTING CERTAIN FEDERAL GRANTS PROHIBITED.
- 2 An entity described by Article 7C.002(a) may not accept federal
- 3 grant funds for the implementation, service, or enforcement of a
- 4 federal statute, order, rule, or regulation purporting to implement
- 5 or enforce an extreme risk protective order against a person in this
- 6 state.
- 7 Art. 7C.005. OFFENSE. (a) A person commits an offense if
- 8 the person serves or enforces or attempts to serve or enforce an
- 9 extreme risk protective order against a person in this state,
- 10 unless the order was issued under the laws of this state.
- 11 (b) An offense under this article is a state jail felony.
- Art. 7C.006. INAPPLICABILITY. This chapter does not apply
- 13 to a protective order issued under the Family Code or the Code of
- 14 Criminal Procedure or to a protective order issued under the laws of
- 15 another state that is recognized or enforceable under the Family
- 16 Code or the Code of Criminal Procedure.
- 17 SECTION 3. This Act takes effect September 1, 2025.
