A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to prohibiting the adoption or use of national sex
- 3 education standards in public schools.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 28.002(b-1), (b-2), and (b-4),
- 6 Education Code, are amended to read as follows:
- 7 (b-1) In this section:
- 8 (1) "Common[, "common] core state standards" means the
- 9 national curriculum standards developed by the Common Core State
- 10 Standards Initiative.
- 11 (2) "National sex education standards" means national
- 12 standards for instruction in human sexuality or sexually
- 13 transmitted diseases, including standards developed by the Future
- 14 of Sex Education Initiative.
- 15 (b-2) The State Board of Education may not adopt common core
- 16 state standards or national sex education standards to comply with
- 17 a duty imposed under this chapter.
- 18 (b-4) Notwithstanding any other provision of this code, a
- 19 school district or open-enrollment charter school may not be
- 20 required to offer any aspect of a common core state standards
- 21 curriculum or any aspect of the national sex education standards.
- SECTION 2. Section 28.004(e), Education Code, is amended to
- 23 read as follows:
- (e) Any course materials and instruction relating to human

- 1 sexuality, sexually transmitted diseases, or human
- 2 immunodeficiency virus or acquired immune deficiency syndrome
- 3 shall be selected by the board of trustees with the advice of the
- 4 local school health advisory council and:
- 5 (1) must:
- 6 (A) [(1)] present abstinence from sexual
- 7 activity as the preferred choice of behavior in relationship to all
- 8 sexual activity for unmarried persons of school age;
- 9 (B) $\frac{\text{(B)}}{\text{(2)}}$ devote more attention to abstinence
- 10 from sexual activity than to any other behavior;
- 11 $\underline{\text{(C)}}$ [$\frac{\text{(3)}}{\text{)}}$] emphasize that abstinence from sexual
- 12 activity, if used consistently and correctly, is the only method
- 13 that is 100 percent effective in preventing pregnancy, sexually
- 14 transmitted diseases, infection with human immunodeficiency virus
- 15 or acquired immune deficiency syndrome, and the emotional trauma
- 16 associated with adolescent sexual activity;
- (D) $[\frac{(4)}{1}]$ direct adolescents to a standard of
- 18 behavior in which abstinence from sexual activity before marriage
- 19 is the most effective way to prevent pregnancy, sexually
- 20 transmitted diseases, and infection with human immunodeficiency
- 21 virus or acquired immune deficiency syndrome; and
- (E) [(5)] teach contraception and condom use in
- 23 terms of human use reality rates instead of theoretical laboratory
- 24 rates, if instruction on contraception and condoms is included in
- 25 curriculum content; and
- 26 (2) may not be based on national sex education
- 27 standards, as defined by Section 28.002(b-1).

- SECTION 3. This Act applies beginning with the 2025-2026
- 2 school year.
- 3 SECTION 4. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2025.
