BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 85.24, Education Code, is amended to 7 read as follows:

Sec. 85.24. UTILITIES. (a) The board [from time to time] 8 may improve and equip existing [central] power plants and may 9 10 construct, acquire, improve, and equip steam plants and additions to steam plants. For the purposes of this subsection, [them, and] 11 12 the board may acquire property [land for these purposes] for the institutions under its  $\operatorname{control}[_{\boldsymbol{\tau}}]$  when the total cost, type of 13 construction, capacity, and plans and specifications have been 14 approved by the board. As used in this section [subsection], "steam 15 plants" does not include electrical generating facilities, but 16 17 "[central] power plants" does include electrical generating facilities. 18

(b) The board [from time to time] may construct, extend, and improve the water systems and[-] sewer systems[-, or both-] for [any or] all institutions under its control[-] when the total cost, type of construction, capacity, and plans and specifications have been approved by the board.

(c) The board may <u>provide</u> [<del>furnish</del>] water, sewer, steam,

power, electricity, or any <u>combination</u> [or all] of those services 1 2 from the [power and steam plant or] plants and other facilities located at each institution to [any or] all [dormitories, kitchens 3 and dining halls, hospitals, student activity buildings, 4 gymnasiums, athletic buildings and stadiums, the dormitory for 5 help, laundry, and other] buildings or facilities that [may] have 6 7 been or may be constructed at each institution, and may determine the amount to be charged as a part of the maintenance and operation 8 9 expense of those buildings or facilities for the service or services. board may allocate the cost of 10 The providing 11 [furnishing] the services to revenue-producing buildings and 12 facilities and to other buildings and facilities at the 13 institutions. The board may pledge the net revenues from the amounts thus received for the services to pay the principal of and 14 15 interest on, and to create and maintain the reserve for, the 16 negotiable revenue bonds issued for the purpose of constructing, acquiring, improving, extending, or equipping the power and steam 17 plants, or additions thereto, or other facilities, and may secure 18 the bonds additionally by pledging rentals, rates, charges, and 19 20 fees for the use or availability of all or any property, buildings, structures, activities, operations, or facilities, of any nature, 21 which may be fixed and collected from all or any designated part of 22 the students enrolled in the institution or institutions or from 23 24 others in the amounts and in the manner determined and provided by 25 the board in the resolution authorizing the issuance of the bonds.
