11 SECTION 2. (a) Section 508.141, Government Code, as 12 amended by this Act, applies to any inmate who is confined in a 13 facility operated by or under contract with the Texas Department of 14 Criminal Justice on or after the effective date of this Act, 15 regardless of whether the offense for which the inmate is confined 16 occurred before, on, or after the effective date of this Act.

(b) The Board of Pardons and Paroles shall adopt a policy consistent with Section 508.141, Government Code, as amended by this Act, as soon as practicable after the effective date of this Act.
