4	SECTION 1. Section 493.035, Government Code, is amended by

6	(c-1) The department shall transfer to the clerk of the
7	court that entered an order of restitution for which the department
8	received notice as described by Subsection (c)(1) a restitution
9	payment derived from unclaimed property for which a claim was filed
10	by the department as described by Subsection (a). The department
11	shall include with the restitution payment the last known address
12	of the victim available to the department, if any.
13	(c-2) The department shall post on the department's
14	Internet website the contact information for a department employee
15	who is able to respond to inquiries from county officials regarding

17	(c-3) Information provided to the clerk of a court under

1 Procedure, the department shall:

2 (1) collect the payment for disbursement to the 3 victim;

4 (2) deposit the payment in the releasee restitution 5 fund; [and]

6 (3) transmit the payment to the clerk of the court that 7 entered the order of restitution as soon as practicable for the 8 clerk to remit the payment to the victim; and

9 <u>(4) provide at the time the payment is transmitted</u> 10 <u>under Subdivision (3) to the clerk of the court that entered the</u> 11 <u>order of restitution the last known address of the victim available</u> 12 <u>to the department, if any</u>.

13 (c-3) Information provided to the clerk of a court under 14 Subsection (c)(4) is confidential and not subject to disclosure 15 under Chapter 552.

16 (e) If a victim who is entitled to restitution does not make a claim for payment before the third [fifth] anniversary of the date 17 the clerk of the court receives the initial restitution payment or 18 if, after the victim makes a claim for payment, the clerk is unable 19 20 to locate the victim for a period of three [five] years after the date the clerk last made a payment to the victim, any unclaimed 21 restitution payments being held by the clerk for payment to the 22 victim are presumed abandoned. The clerk of the court shall report 23 24 and deliver to the comptroller all unclaimed restitution payments presumed abandoned under this section in the manner provided by 25 26 Chapter 77, Property Code.

27 SECTION 3. This Act takes effect September 1, 2025.
