17	(A) an explosive weapon;
18	(B) a machine gun; [or]
19	(C) a short-barrel firearm; or
20	(D) a device designed and intended solely and
21	exclusively to make a handgun capable of shooting automatically
22	more than two shots, without manual reloading, by a single function
23	of the trigger;

(2) armor-piercing ammunition;

- 1 (3) a chemical dispensing device;
- 2 (4) a zip gun;
- 3 (5) a tire deflation device; or
- 4 (6) an improvised explosive device.
- 5 SECTION 2. The change in law made by this Act applies only
- 6 to an offense committed on or after the effective date of this Act.
- 7 An offense committed before the effective date of this Act is
- 8 governed by the law in effect on the date the offense was committed,
- 9 and the former law is continued in effect for that purpose. For
- 10 purposes of this section, an offense was committed before the
- 11 effective date of this Act if any element of the offense occurred
- 12 before that date.
- SECTION 3. This Act takes effect September 1, 2025.
