- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 5003.051, Special District Local Laws
- 6 Code, is amended to read as follows:
- 7 Sec. 5003.051. BOARD OF NAVIGATION COMMISSIONERS. The port
- 8 authority is governed by a board of  $\underline{\text{seven}}$  [ $\underline{\text{six}}$ ] commissioners.
- 9 SECTION 2. Section 5003.053, Special District Local Laws
- 10 Code, is amended to read as follows:
- 11 Sec. 5003.053. ELECTION; TERMS. (a) One commissioner is
- 12 elected by the voters of the entire port authority. One
- 13 commissioner is elected from each of the six navigation
- 14 commissioner precincts as described by Section 5003.052.
- 15 (b) The [six] commissioners who represent the six precincts
- 16 who are elected at the first election after a division of the port
- 17 authority into new precincts under Section 5003.052 shall draw lots
- 18 after the election to select three commissioners to serve two-year
- 19 terms and three commissioners to serve four-year terms. Successor
- 20 commissioners serve terms as provided by Subsection  $\underline{(c)}$  [ $\frac{(b)}{(b)}$ ].
- 21 (c) [ $\frac{(b)}{(b)}$ ] Except as provided by Subsection (b) [ $\frac{(a)}{(a)}$ ],
- 22 commissioners are elected for staggered four-year terms at
- 23 elections held each odd-numbered year on the uniform election date
- 24 in May.

- 1 SECTION 3. Section 5003.054(b), Special District Local Laws
- 2 Code, is amended to read as follows:
- 3 (b) The application must include an affidavit made by the
- 4 applicant under oath disclosing that the applicant is:
- 5 (1) a bona fide resident of:
- 6 (A) if the applicant seeks to represent a
- 7 precinct, the precinct that the person seeks to represent; or
- 8 <u>(B) if the applicant seeks to represent the port</u>
- 9 <u>authority at large, the port authority;</u> and
- 10 (2) a qualified voter who owns real property in the
- 11 area.
- 12 SECTION 4. (a) The Calhoun Port Authority shall hold the
- 13 first election to elect an at-large commissioner, as provided by
- 14 Section 5003.053, Special District Local Laws Code, as amended by
- 15 this Act, on the uniform election date in May 2027.
- 16 (b) Not later than the 30th day after the effective date of
- 17 this Act, the governor shall appoint an at-large commissioner to
- 18 the board of the Calhoun Port Authority to serve a term that expires
- 19 on the date that the candidate elected to the office of the at-large
- 20 commissioner in May 2027 qualifies to serve. The person appointed
- 21 by the governor must meet the qualifications provided by Section
- 22 5003.054(b), Special District Local Laws Code, as amended by this
- 23 Act.
- SECTION 5. (a) The legal notice of the intention to
- 25 introduce this Act, setting forth the general substance of this
- 26 Act, has been published as provided by law, and the notice and a
- 27 copy of this Act have been furnished to all persons, agencies,

- 1 officials, or entities to which they are required to be furnished
- 2 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 3 Government Code.
- 4 (b) The governor, one of the required recipients, has
- 5 submitted the notice and Act to the Texas Commission on
- 6 Environmental Quality.
- 7 (c) The Texas Commission on Environmental Quality has filed
- 8 its recommendations relating to this Act with the governor, the
- 9 lieutenant governor, and the speaker of the house of
- 10 representatives within the required time.
- 11 (d) All requirements of the constitution and laws of this
- 12 state and the rules and procedures of the legislature with respect
- 13 to the notice, introduction, and passage of this Act are fulfilled
- 14 and accomplished.
- 15 SECTION 6. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2025.
