## A BILL TO BE ENTITLED

- 2 relating to the creation of a task force to evaluate the housing
- 3 needs of senior citizens who are lesbian, gay, bisexual,
- 4 transgender, queer, or questioning.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. (a) In this section, "task force" means the task
- 7 force established under this section.
- 8 (b) The task force is established to evaluate the housing
- 9 needs of senior citizens who are lesbian, gay, bisexual,
- 10 transgender, queer, or questioning and to develop potential housing
- 11 solutions to address those needs and provide to those senior
- 12 citizens safe, affordable housing options. In conducting the
- 13 evaluation, the task force shall assess the evolving housing needs
- 14 of senior citizens who may need to transition into a long-term care
- 15 facility, including an assisted living facility or a nursing
- 16 facility.
- 17 (c) The task force is composed of the following 10 members:
- 18 (1) the chair of the LGBTQ caucus of the house of
- 19 representatives, to serve as presiding officer of the task force;
- 20 (2) three members appointed by the governor;
- 21 (3) three members appointed by the lieutenant
- 22 governor; and
- 23 (4) three members appointed by the speaker of the
- 24 house of representatives.

- 1 (d) In making the appointments under Subsection (c) of this
- 2 section, the governor, the lieutenant governor, and the speaker of
- 3 the house of representatives shall each:
- 4 (1) seek input from appropriately qualified
- 5 organizations and stakeholders, including the Coalition for Aging
- 6 LGBT and Equality Texas; and
- 7 (2) appoint:
- 8 (A) an appropriately qualified individual who is
- 9 a representative of the lesbian, gay, bisexual, transgender, queer,
- 10 or questioning community;
- 11 (B) an individual with appropriate expertise on
- 12 issues faced by the aging population who may be a representative of
- 13 the Coalition for Aging LGBT, assisted living facilities, or
- 14 nursing facilities; and
- 15 (C) an individual with appropriate expertise in
- 16 the area of public safety and housing who may be a representative of
- 17 the Texas Department of Housing and Community Affairs.
- 18 (e) The governor, the lieutenant governor, and the speaker
- 19 of the house of representatives shall each make the appointments
- 20 required by Subsection (c) of this section not later than November
- 21 1, 2025.
- 22 (f) The task force shall meet at the call of the presiding
- 23 officer. The task force may meet in person or by electronic means.
- 24 (g) A task force member is not entitled to compensation for
- 25 service on the task force but may be reimbursed for actual and
- 26 necessary expenses incurred in performing task force duties. The
- 27 task force may accept gifts, grants, and donations to pay for those

- 1 expenses.
- 2 (h) Not later than September 1, 2026, the task force shall
- 3 prepare and submit to the governor, the lieutenant governor, the
- 4 legislature, and the Texas Department of Housing and Community
- 5 Affairs a written report summarizing the results of the evaluation
- 6 conducted under Subsection (b) of this section and proposing
- 7 potential housing solutions, including any legislative
- 8 recommendations.
- 9 (i) The task force is abolished and this Act expires
- 10 December 1, 2026.
- 11 SECTION 2. This Act takes effect September 1, 2025.
