S.B. No. 1862

A BILL TO BE ENTITLED

AN ACT

relating to interstate notification by the voter registrar of certain applicants for voter registration.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 13.002(c), Election Code, is amended to read as follows:

(c) A registration application must include:

(1) the applicant's first name, middle name, if any, last name, and former name, if any;

(2) the month, day, and year of the applicant's birth;

(3) a statement that the applicant is a United States citizen;

(4) a statement that the applicant is a resident of the county;

(5) a statement that the applicant has not been determined by a final judgment of a court exercising probate jurisdiction to be:

(A) totally mentally incapacitated; or

(B) partially mentally incapacitated without the right to vote;

(6) a statement that the applicant has not been finally convicted of a felony or that the applicant is a felon eligible for registration under Section 13.001;

(7) the applicant's residence address or, if the

1 residence has no address, the address at which the applicant
2 receives mail and a concise description of the location of the
3 applicant's residence;

4 (8) the following information:

5 (A) the applicant's Texas driver's license number
6 or the number of a personal identification card issued by the
7 Department of Public Safety;

8 (B) if the applicant has not been issued a number
9 described by Paragraph (A), the last four digits of the applicant's
10 social security number; or

11 (C) a statement by the applicant that the
12 applicant has not been issued a number described by Paragraph (A) or
13 (B);

14 (9) if the application is made by an agent, a statement
15 of the agent's relationship to the applicant; and

16 (10) the address, including the city and county, where
17 ~~[in which]~~ the applicant formerly resided.

18 SECTION 2. Section [13.072](#), Election Code, is amended by
19 adding Subsections (e), (f), and (g) to read as follows:

20 (e) If a voter registration application indicates the
21 applicant's previous residence was outside of this state, the voter
22 registrar shall document the applicant's full legal name, date of
23 birth, current address of residence, and previous address of
24 residence.

25 (f) The voter registrar shall compile the information
26 described by Subsection (e) to produce a monthly report. The
27 monthly report must be submitted to the secretary of state. The

1 monthly report must include the following for each voter:

2 (1) full legal name;

3 (2) date of birth;

4 (3) social security number, if provided;

5 (4) driver's license number, if provided;

6 (5) voter unique identifier number;

7 (6) current address of residence; and

8 (7) previous address of residence.

9 (g) On a monthly basis, the secretary of state shall, with
10 the information provided from the report submitted under Subsection
11 (f), notify the voter registrar with jurisdiction over the previous
12 residence of a voter described by Subsection (e) that the voter may
13 be removed from that jurisdiction's voter registration list.

14 SECTION 3. This Act takes effect September 1, 2025.
