## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the discharge or use of certain firefighting foams for
3	testing or training.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 501, Health and Safety
6	Code, is amended by adding Section 501.027 to read as follows:
7	Sec. 501.027. DISCHARGE OR USE OF CERTAIN FIREFIGHTING
8	FOAMS PROHIBITED FOR TESTING OR TRAINING. (a) In this section:
9	(1) "Fixed foam system" means a complete installation
10	engineered for flammable liquid fire hazards that discharges
11	through a fixed discharge device foam piped from a central foam
12	station onto a flammable liquid fire hazard. The installation must
13	have permanently installed foam proportioning components and may
14	contain multiple listed components and foam.
15	(2) "Perfluoroalkyl and polyfluoroalkyl chemicals"
16	means non-polymeric perfluoroalkyl substances, saturated
17	polyfluoroalkyl substances, and side-chain fluorinated polymers
18	that contain at least two fully fluorinated sequential carbon
19	atoms. The term does not include gases or substances that become
20	gases in use that are otherwise regulated by state or federal laws,
21	rules, or regulations, or by international protocols.
22	(3) "Testing facility" means a facility, including a
23	facility used for firefighter training, that allows for the
24	discharge of firefighting foam in a nonemergency situation for the

evaluation and calibration of firefighting equipment and foam. 1 2 (b) A person may not discharge a Class B firefighting foam 3 designed to extinguish flammable liquid fires that contains 4 intentionally added perfluoroalkyl and polyfluoroalkyl chemicals: 5 (1) during or for the training of firefighters; or (2) during or for testing, including calibration 6 7 testing, conformance testing, or fixed foam system testing, unless 8 the discharge or use: 9 (A) is otherwise: 10 (i) required by law or a rule or order of 11 the applicable state agency or political subdivision; or 12 (ii) necessary to meet applicable National 13 Fire Protection Association standards; and (B) occurs in a testing facility that has 14 implemented appropriate containment, treatment, and disposal 15 16 measures to prevent the release of the foam into the environment. (c) A person shall use a non-fluorinated firefighting 17 training foam or other non-fluorinated surrogate during or for the 18 training of firefighters. Training that uses a non-fluorinated 19 20 firefighting training foam or other non-fluorinated surrogate under this subsection must be conducted in a manner that ensures 21 collection of the used foam or surrogate, regardless of the foam or 22 23 surrogate type. 24 This section does not prohibit or restrict: (d) 25 (1) the manufacture, sale, or distribution of firefighting foam that contains intentionally added perfluoroalkyl 26 27 and polyfluoroalkyl chemicals; or

4	SECTION 2. This Act takes effect September 1, 2025.
