13	supplement benefit plan to individuals 65 years of age or older must
14	offer the same coverage to individuals younger than 65 years of age
15	who are eligible for and enrolled in Medicare by reason of
16	disability or end stage renal disease.
17	(c) Except as otherwise provided by rules adopted under
18	Section 1652.051, any benefit, protection, policy, or procedure
19	applicable to coverage under a plan for an individual 65 years of
20	age or older must apply to coverage offered under Subsection (b).
21	(d) An entity shall offer a plan under Subsection (b) at the
22	same premium rate charged for that plan to an individual 65 years of
23	age.

(a) In this section, "entity" 1 2 means an entity that delivers or issues for delivery a Medicare 3 supplement benefit plan in this state. 4 (b) An individual eligible for coverage under a Medicare 5 supplement benefit plan under Section 1652.059 may enroll any time 6 during: 7 (1) the six-month period beginning the first day of 8 the first month the individual becomes enrolled for benefits under Medicare Part B; 9 10 (2) a 60-day open enrollment period each year beginning on the date of the individual's birth; or 11 12 (3) a special enrollment period designated by the 13 commissioner. 14 (c) During an enrollment period, an entity may not: 15 (1) deny or condition the issuance or effectiveness of a Medicare supplement benefit plan or certificate that the entity 16 offers and is available for issuance in this state; 17 (2) subject an applicant to medical underwriting or 18 19 discriminate in the price of a Medicare supplement benefit plan or certificate because of the applicant's health status, claims 20 experience, receipt of health care, or medical condition; or 21 (3) impose an exclusion of benefits based on an 22 applicant's preexisting condition. 23 24 The commissioner shall adopt rules as necessary to (d) administer this section, including rules designating enrollment 25 26 periods. SECTION 2. The changes in law made by this Act apply only to 27

(1) after August 31, 2025, and before March 2, 2026; or (2) if the individual is unable to submit an application for coverage under the plan during the period described by Subdivision (1) of this section because the application is not available and the individual requested the application during that period, during a six-month period beginning on the date the application initially becomes available.

SECTION 4. This Act takes effect September 1, 2025.
