4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle Z, Title 10, Government Code, is
6	amended by adding Chapter 3001 to read as follows:
7	CHAPTER 3001. RESTRICTIONS ON CERTAIN FIRE REGULATIONS
8	Sec. 3001.001. DEFINITIONS. In this chapter:
9	(1) "Agricultural pole barn" means a nonresidential
10	farm building in which 70 percent or more of the perimeter walls are
11	permanently open and allow free ingress and egress.
12	(2) "Governmental entity" has the meaning assigned by
13	Section 2007.002.
14	(3) "Livestock market" has the meaning assigned by
15	Section 161.111, Agriculture Code.
16	(4) "Nonresidential farm building" means any
17	temporary or permanent building on a farm, ranch, or other
18	agricultural facility that is used primarily for agricultural
19	purposes and not intended to be used as a residential dwelling. The
20	term includes a barn, greenhouse, shade house, farm office, storage
21	building, workshop, poultry house, animal handling facility, or
22	commodity storage and feed processing facility.
23	Sec. 3001.002. RESTRICTION ON REGULATION OF CERTAIN
24	AGRICULTURAL FACILITIES. Notwithstanding any other law, a

1	governmental entity may not adopt or enforce an ordinance, order,
2	rule, or other measure that requires the installation of a fire
3	protection sprinkler system in:
4	(1) an agricultural pole barn;
5	(2) a nonresidential farm building;
6	(3) a cotton gin;
7	(4) a cottonseed storage building;
8	(5) a grain storage facility;
9	(6) a livestock market; or
10	(7) a commercial feed mill.
11	SECTION 2. This Act takes effect September 1, 2025.
