- 2 relating to participation in the Texas Leadership Scholars Program.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 61.891, Education Code, is amended by
- 5 adding Subdivision (4) to read as follows:
- 6 (4) "Eligible institution" means a general academic
- 7 teaching institution as defined by Section 61.003.
- 8 SECTION 2. Section 61.897, Education Code, is amended by
- 9 amending Subsection (a) and adding Subsection (a-1) to read as
- 10 follows:
- 11 (a) The board, in consultation with general academic
- 12 teaching institutions, shall adopt rules for the administration of
- 13 the program, including rules providing for the amount and
- 14 permissible uses of a scholarship awarded under the program. The
- 15 rules must provide that:
- 16 (1) the amount of a research scholarship is at least
- 17 150 percent of the amount of a leadership scholarship; [and]
- 18 (2) a student may not receive a scholarship under
- 19 <u>either</u> the <u>leadership</u> or <u>research scholarship</u> program for more than
- 20 four years per student per program; and
- 21 (3) each eligible institution receives at least one
- 22 research scholarship award with remaining research scholarships
- 23 awarded to eligible institutions based, in part, on the number of
- 24 research doctoral degrees awarded by each institution.

- 1 (a-1) In adopting rules under this subchapter, the board may
- 2 not adopt a rule that:
- 3 (1) limits the general academic teaching institutions
- 4 that may participate in the program; or
- 5 (2) gives preference to students enrolled in certain
- 6 general academic teaching institutions.
- 7 SECTION 3. As soon as practicable after the effective date
- 8 of this Act, the Texas Higher Education Coordinating Board shall
- 9 adopt rules to implement Section 61.897, Education Code, as
- 10 amended by this Act.
- 11 SECTION 4. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2025.
