- 2 relating to the establishment of a work group to conduct a study on
- 3 the feasibility of implementing an acute psychiatric bed registry.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) In this section:
- 6 (1) "Commission" means the Health and Human Services
- 7 Commission.
- 8 (2) "Executive commissioner" means the executive
- 9 commissioner of the commission.
- 10 (3) "Inpatient mental health facility" has the meaning
- 11 assigned by Section 571.003, Health and Safety Code.
- 12 (b) The commission shall establish a work group to conduct a
- 13 study on the feasibility of implementing a statewide or regional
- 14 acute psychiatric bed registry to list available beds at inpatient
- 15 mental health facilities for the inpatient psychiatric treatment of
- 16 certain individuals.
- 17 (c) The work group consists of the following members
- 18 appointed by the executive commissioner:
- 19 (1) the chair of the Texas Hospital Association or the
- 20 chair's designee;
- 21 (2) the president of the Texas Medical Association or
- 22 the president's designee;
- 23 (3) the president of the Texas Nurses Association or
- 24 the president's designee;

- 1  $\qquad$  (4) two members who are experts in the field of
- 2 technology;
- 3 (5) one member who is a licensed psychiatrist;
- 4 (6) one member who is a licensed professional
- 5 counselor, as defined by Section 503.002, Occupations Code;
- 6 (7) one member who works in a substance use treatment
- 7 facility;
- 8 (8) one member who is a representative of a hospital
- 9 located in a rural area of this state;
- 10 (9) one member who is a representative of a hospital
- 11 located in a county with a population of four million or more;
- 12 (10) one member who is a representative of a hospital
- 13 located in an urban area of this state in a county with a population
- 14 of less than four million;
- 15 (11) one member who is a representative of a public
- 16 hospital;
- 17 (12) one member who is a representative of a private
- 18 hospital;
- 19 (13) one member who is a statistician;
- 20 (14) one member who is a public health expert; and
- 21 (15) any other member with appropriate expertise as
- 22 the executive commissioner determines necessary.
- 23 (d) The work group shall elect from among the membership a
- 24 presiding officer.
- (e) The work group shall meet periodically and at the call
- 26 of the presiding officer.
- 27 (f) Not later than November 1, 2027, the commission shall

- 1 prepare and submit to each standing committee of the senate and
- 2 house of representatives having primary jurisdiction over mental
- 3 health a written report that summarizes the results of the study
- 4 conducted under this section. The report must:
- 5 (1) evaluate the effect of bed registries;
- 6 (2) include recommendations for increasing public
- 7 awareness of bed registries;
- 8 (3) include recommendations for leveraging financial
- 9 incentives and legislative, regulatory, or contractual mechanisms
- 10 to expedite the entry of data for bed registries;
- 11 (4) assess the effect of hospital reimbursements in
- 12 increasing bed availability;
- 13 (5) evaluate psychiatric treatment capacity in
- 14 relation to bed availability; and
- 15 (6) include any other information the commission
- 16 considers necessary.
- 17 (g) The work group is abolished and this section expires
- 18 November 1, 2028.
- 19 SECTION 2. As soon as practicable after the effective date
- 20 of this Act, the executive commissioner of the Health and Human
- 21 Services Commission shall appoint the members to the work group
- 22 established by this Act.
- 23 SECTION 3. This Act takes effect September 1, 2025.
