S.B. No. 2932

A BILL TO BE ENTITLED

AN ACT

relating to a pilot program awarding grants for the provision of personalized treatment protocols for veterans diagnosed with post-traumatic stress disorder.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle B, Title 2, Health and Safety Code, is amended by adding Chapter 49 to read as follows:

CHAPTER 49. VETERANS PILOT PROGRAM TO PROVIDE POST-TRAUMATIC
STRESS DISORDER TREATMENT

Sec. 49.001. DEFINITIONS. In this chapter:

(1) "Pilot program" means the pilot program established under this chapter.

(2) "Veteran" means an individual who has served in:

(A) an active or reserve component of the army, navy, air force, coast guard, or marine corps of the United States; or

(B) the Texas National Guard, as defined by Section 431.001, Government Code.

Sec. 49.002. ESTABLISHMENT AND OPERATION OF PILOT PROGRAM.

(a) The commission, using available resources and in cooperation with a nonprofit veterans organization, shall establish and operate a pilot program to award grants for the provision of personalized treatment protocols to at least 250 veterans diagnosed with post-traumatic stress disorder, including treatment-resistant

1 post-traumatic stress disorder.

2 (b) A personalized treatment protocol provided to a veteran
3 under the pilot program:

4 (1) must be:

5 (A) administered at the veteran's home; and

6 (B) designed to reduce neuroinflammation and
7 replenish deficient or insufficient brain chemistry to an optimal
8 level; and

9 (2) may not include the provision of:

10 (A) a narcotic drug, as defined by Section
11 [481.002](#);

12 (B) a psychedelic drug; or

13 (C) a psychotropic medication, as defined by
14 Section [266.001](#), Family Code.

15 (c) The commission may award a grant under the pilot program
16 only in accordance with a contract between the commission and a
17 grant recipient. The contract must include provisions under which
18 the commission is granted sufficient control to ensure the public
19 purpose of providing treatment to veterans is accomplished and the
20 state receives the return benefit.

21 (d) The commission may accept gifts, grants, and donations
22 to operate the pilot program.

23 Sec. 49.003. RULES. The executive commissioner shall adopt
24 rules to implement this chapter.

25 Sec. 49.004. REPORT. Not later than October 1, 2030, the
26 commission shall prepare and submit to the governor, the lieutenant
27 governor, the speaker of the house of representatives, and the

1 appropriate standing committees of the legislature a report that
2 includes:

3 (1) information on the number of veterans who were
4 provided a personalized treatment protocol under the pilot program;
5 and

6 (2) an evaluation of the pilot program's
7 effectiveness.

8 Sec. 49.005. EXPIRATION. The pilot program concludes and
9 this chapter expires September 1, 2031.

10 SECTION 2. As soon as practicable after the effective date
11 of this Act:

12 (1) the executive commissioner of the Health and Human
13 Services Commission shall adopt the rules necessary to implement
14 Chapter 49, Health and Safety Code, as added by this Act; and

15 (2) the Health and Human Services Commission shall
16 establish and begin operating the pilot program under Chapter 49,
17 Health and Safety Code, as added by this Act.

18 SECTION 3. This Act takes effect September 1, 2025.
